IN THE MATTER OF THE SPECIAL DEPUTIZATION OF THE DEPARTMENT OF EDUCATION, THE PHILIPPINE NATIONAL POLICE, AND THE OFFICE OF THE MUNICIPAL TREASURER OF THE **ORIGINAL** MUNICIPALITIES OF THE SIXTY-THREE (63) **BARANGAYS** WHO VOTED TO BE INCLUDED IN THE BANGSAMORO **AUTONOMOUS** REGION IN MUSLIM MINDANAO IN CONNECTION WITH THE OCTOBER 2023 BARANGAY SANGGUNIANG KABATAAN ELECTIONS

RESOLUTION NO. 10906

WHEREAS, sixty-three (63) of the sixty-seven (67) barangays from the six (6) municipalities of North Cotabato voted for their inclusion in the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) during the 2019 plebiscite;

WHEREAS, these barangays came from the following municipalities: seven (7) from Carmen, seven (7) from Kabacan, thirteen (13) from Midsayap, twelve (12) from Pigcawayan, two (2) from Aleosan, and twenty-two (22) from Pikit;

WHEREAS, these barangays have already been included in the territorial jurisdiction of the BARMM but have not been reconstituted yet into specific local government units under the Bangsamoro Organic Law;

WHEREAS, pending the creation of the municipalities in the BARMM that will cover the sixty-three (63) barangays, there is a need to identify the local offices which shall assume jurisdiction over these barangays for purposes of appointment of poll workers, distribution of the ballots and other accountable forms and security preparation during the October 30, 2023 Barangay and Sangguniang Kabataan Elections;

NOW THEREFORE, pursuant to the powers and functions of the Commission under the Constitution, the Omnibus Election Code, as amended, and other existing laws, the Commission **RESOLVED**, as it hereby **RESOLVES**, to deputize:

- 1. The Public School District Supervisor;
- 2. Municipal Treasurer; and
- 3. The Chief of Police and Personnel of the Municipal Police Stations

of the following municipalities, with respect to the following barangays for purposes of the October 30, 2023 BSKE:

As special deputies, they have the following functions in coordination with the proper offices of the BARMM:

A. The Public School District Supervisors

1. To provide the list of recommended Electoral Board, Department of Education Supervising Official and other poll workers who will serve in the voting centers and polling places in the said barangays.

B. Municipal Treasurers

1. To receive and take custody of the ballots and other accountable forms and supplies and distribute them to the Electoral Board in the said barangays, in accordance with the rules.

- C. The Municipal Police Stations, Officers and Personnel
 - 1. To maintain the peace and order as well as security in the barangays, including the voting centers situated therein;

This deputization is in addition to the general powers and functions given to the Department of Education, the Municipal Treasurer and the Philippine National Police as regular deputies of the Commission on Elections during the October 30, 2023 Barangay and Sangguniang Kabataan Elections.
