THIRD LEGISLATIVE ASSEMBLY (Third Regular Session)

Begun and held in Cotabato City, on Monday, the twenty seventh day of April, nineteen hundred and ninety eight.

[MUSLIM MINDANAO AUTONOMY ACT NO. 64]

AN ACT CREATING BARANGAY SUMAKUBAY IN THE MUNICIPALITY OF GENERAL SALIPADA K. PENDATUN, PROVINCE OF MAGUINDANAO, AND FOR OTHER PURPOSES.

Be it enacted by the Regional Legislative Assembly in session assembled:

SECTION 1. The Sitio Sumakubay is hereby separated from its mother barangay of Makainis in the Municipality of General Salipada K. Pendatun, Province of Maguindanao, created and constituted into a separate and distinct barangay in the same municipality.

SEC. 2. Barangay Sumakubay shall be bounded as follows:

"Beginning at the barangay road due North and the natural boundaries of Barangay Sipon on the West; thence, Barangay Pualas on the South and Barangay Poblacion Badak on the East; and all the boundaries designated between and among the adjoining barangays situated therein."

SEC. 3. The barangay is a corporate entity with jurisdiction in all matters provided by Muslim Mindanao Autonomy Act No. 25 and other pertinent existing laws.

SEC. 4. The barangay shall be composed of a Punong Barangay, as the chief executive, and the seven (7) regular members and the chairman of the Sangguniang Kabataan, as members of the Sangguniang Barangay. The Punong Barangay and the regular members of the Sangguniang Barangay shall all be elected at large.



- SEC. 5. The barangay appointive officials shall be appointed by the Punong Barangay with the concurrence of the majority of all the members of the Sangguniang Barangay.
- SEC. 6. Initially, the Punong Barangay and regular members of the Sangguniang Barangay shall be appointed by the Municipal Mayor of the Municipality concerned immediately after the plebiscite called for the purpose and shall continue to hold office until their successors shall have been elected and qualified following their election. The Chairman of the Sangguniang Kabataan shall be appointed by the Punong Barangay until his successor shall have been elected and qualified in the next Sangguniang Kabataan regular election.
- SEC. 7. The Commission on Elections shall conduct and supervise the plebiscite for the purpose which shall be called by the Municipal Mayor within ninety (90) days after the approval of this Act.
- 8. The expenses necessary in holding plebiscite shall be drawn out of any available funds not otherwise appropriated in the Office of the Municipal Treasurer of the Municipality of S.K. Pendatun, Maguindanao as may be determined by its Sangguniang Bayan.

SEC. 9. This Act shall take effect immediately after its approval.
