THIRD LEGISLATIVE ASSEMBLY (Third Regular Session)

Begun and held in Cotabato City, on Monday, the twenty seventh day of April, nineteen hundred and ninety eight.

[MUSLIM MINDANAO AUTONOMY ACT NO. 65]

AN ACT CREATING BARANGAY PANGANALAGA IN THE MUNICIPALITY OF GEN. SALIPADA K. PENDATUN, PROVINCE OF MAGUINDANAO, AND FOR OTHER PURPOSES.

Be it enacted by the Regional Legislative Assembly in session assembled:

SECTION 1. The Sitios of Panganalaga and Ngaday in Barangay Bulod, Sitios Tual and Matilak in Barangay Upper Idtig, Sitios Upper Bagundang and Kawayan in Barangay Ramcor, and Sitios Papandayan and Sautin in Barangay Midconding, all in the Municipality of Gen. Salipada K. Pendatun, Province of Maguindanao are hereby separated from their respective mother Barangays and are created into a separate and distinct regular barangay to be known as Barangay Panganalaga in the same municipality and province.

SEC. 2. This Barangay is bounded by natural and duly designated boundaries, more specifically as follows:

"Beginning at a point along the bank of Buluan River at Sitio Tual and moving Southwest approximately 850 meters towards point-2 near Sitio Matilak; thence, moving northwest of about 1.8 kilometers towards point-3, which excludes Sitios Adteban and Uno Dos located at the outskirts of the proposed barangay; from here, it moves southwest approximately 2.4 kilometers to point-4, then follows a southeasternly direction approximately 500 meters towards point-5,

which is the boundary point of Sitios Upper Bagundang and Lower Bagundang; thence moves southwest of about 1.55 kilometers towards point-6, then goes northwest approximately 800 meter towards point-7 in Sitio Sautin passing through Sitio Kawayan; from point-7 it moves northeast approximately 650 meters to point-8 and then moves southeast for 200 meters; from here, it goes northeast zigzagging its way for about 1.8 kilometers; then moves northwest approximately 750 meter towards point-11 near Sitio Ngaday; from this point, it proceeds northeast for about 1.05 moves northwest kilometers; then approximately 150 meters; thence it moves northeast for approximately 1.45 kilometers towards the bank of Buluan River, then traverse following the flow of said river back to point-1."

- SEC. 3. The Barangay is a corporate entity with jurisdiction in all matters defined and provided for in Muslim Mindanao Autonomy Act No. 25, other existing laws and regulations.
- SEC. 4. The Barangay Council shall be composed of a Punong Barangay as chief executive and the seven (7) regular members of the Sangguniang Barangay and the Chairman of the Sangguniang Kabataan, as members.
- SEC. 5. The barangay appointive officials shall be appointed by the Punong Barangay with the concurrence of the majority of all the members of the Sangguniang Barangay.
- SEC. 6. Initially, the Punong Barangay and the regular members of the Sangguniang Barangay shall be appointed by the Municipal Mayor of the Municipality concerned immediately after the plebiscite called for the purpose and shall continue to hold office until their successors shall have been elected and qualified following their election. The Chairman of the Sangguniang Kabataan shall be appointed by the Punong Barangay until his successor shall have been elected and qualified in the next Sangguniang Kabataan regular election.



- SEC. 7. The seat of the barangay government shall be at Panganalaga.
- SEC. 8. The Commission on Elections shall conduct and supervise the plebiscite for the purpose which shall be called by the Municipal Mayor within ninety (90) days after the approval of this Act.
- SEC. 9. The expenses necessary in holding the plebiscite shall be drawn out of any available funds not otherwise appropriated in the Office of the Municipal Treasurer of the Municipality of S.K. Pendatun, Maguindanao as may be determined by its Sangguniang Bayan.

SEC. 10. This Act shall take effect immediately after its approval.
