[MUSLIM MINDANAO AUTONOMY ACT NO. 75]

AN ACT CREATING BARANGAY PIDTIGUIAN IN THE MUNICIPALITY OF GENERAL SALIPADA K. PENDATUN, PROVINCE OF MAGUINDANAO, AND FOR OTHER PURPOSES.

Be it enacted by the Regional Legislative Assembly in session assembled:

SECTION 1. The Sitio Pidtiguian is hereby elevated into a separate and distinct barangay out of its mother Barangay Lao-Lao, in the Municipality of Gen. Salipada K. Pendatun, Province of Maguindanao.

SEC. 2. The territorial jurisdiction of the proposed barangay shall be defined by the following technical description, to wit:

N 55 - 28 W 740.66 M. From BLIM No. 1 PLS 73 to point 1, point of beginning, hence:

SEC. 3. The Sangguniang Barangay shall, taking into consideration accessibility and centrality, determine and fix the seat of government of Barangay Pidtiguian.



- SEC. 4. Immediately after the ratification of this Act, the punong barangay and seven (7) members of the sangguniang barangay shall be appointed by the mayor of General Salipada K. Pendatun Municipality; while the chairman and seven (7) members of the sangguniang kabataan shall be appointed by the concerned punong barangay: Provided, That they shall hold office until their successors shall have been duly elected and qualified in their next sangguniang regular elections: Provided, Further, That they shall exercise their duties and powers specified under Republic Act 6734, Muslim Mindanao Autonomy Act 25, and other existing rules and regulations.
- SEC. 5. The corporate existence of Barangay Pidtiguian shall commence upon the appointment and qualification of the punong barangay and a majority of the sangguniang members.
- SEC. 6. The sangguniang bayan shall provide for the allowances and benefits of the appointed barangay officials out of the municipal funds until the regular allocation from the national government shall have been released to the new barangay.
- SEC. 7. The Commission on Elections shall conduct and supervise the plebiscite within ninety (90) days after the approval of this Act.
- SEC. 8. The expenses required for the plebiscite shall be appropriated out of any available funds in the treasury of the municipality of General Salipada K. Pendatun as may be determined by its sangguniang bayan.

SEC. 9. This Act shall take effect upon its approval.
