[MUSLIM MINDANAO AUTONOMY ACT NO. 78]

"AN ACT CREATING BARANGAY CARANDANGAN IN THE MUNICIPALITY OF BUBONG, PROVINCE OF LANAO DEL SUR, AND FOR OTHER PURPOSES."

Be it enacted by the Regional Legislative Assembly in session assembled.

- SECTION 1. Barangay Carandangan is hereby created as a separate and distinct political unit from Barangay Rogero in the Municipality of Bubong, Province of Lanao del Sur.
- SEC. 2. The territorial jurisdiction of Barangay Carandangan is bounded by natural and duly designated boundaries, more specifically described as follows:

From the point of origin, Point 1, the line moves northwest for 2,980.94 meters, passing through the Road towards Point 2; thence Provincial southwestward for 566.28 meters to Point 3; thence going northwest for 896.45 meters towards a point along the Sigayan River to Point 4; thence moving northeasterly for 432.55 meters following the contour of the river to Point 5; thence moving northwest for meters towards Point 6; thence northwest for 371.30 meters to Point 7; thence going 298.09 meters northeast towards Point 8; thence northwestward for 374.29 meters ·moving Point 9; thence moving southeast for 1,653.26 meters ending along a point on the Provincial Road towards Point 10; thence continuing southeast for 2,370.99 meters to Point 11; thence moving southeast for 2,047.89 meters, going back to the point of origin, more or less containing an area of 670 hectares."

- SEC. 3. Immediately after the ratification of this Act, the punong barangay and seven (7) members of the sangguniang barangay shall be appointed by the mayor of Bubong Municipality; while the chairman and seven (7) members of the sangguniang kabataan shall be appointed by the concerned punong barangay: Provided, That they shall hold office until their successors shall have been duly elected and qualified in their next sangguniang regular elections: Provided, Further, That they shall exercise their duties and powers specified under Republic Act 6734, Muslim Mindanao Autonomy Act 25, and other existing rules and regulations.
- SEC. 4. The corporate existence of Barangay Carandangan shall commence upon the appointment and qualification of the punong barangay and a majority of the sangguniang members.
- SEC. 5. The sangguniang bayan shall provide for the necessary allowances and other benefits of the appointed barangay officials out of the municipal funds until the regular allocation from the national government shall have been released to the new barangay.
- SEC. 6 The Commission on Elections shall conduct and supervise the plebiscite which shall be held within ninety (90) days after the approval of this Act.
- SEC. 7. The expenses required for the plebiscite shall be appropriated out of any available funds in the treasury of the municipality of Bubong as may be determined by its sangguniang bayan.
 - SEC. 8. This Act shall take effect upon its approval.
