[MUSLIM MINDANAO AUTONOMY ACT 82]

AN ACT CREATING BARANGAY GADUNGANPEDPANDARAN IN THE MUNICIPALITY OF PARANG, PROVINCE OF MAGUINDANAO, AND FOR OTHER PURPOSES.

Be it enacted by the Regional Legislative Assembly in session assembled:

SECTION 1. The Sitios of Gadunganpedpandaran, Malalis, Malacao, Amay Martin, Sanday, Sumagka, Baclayan, Dongon, Naga, Etel, Manding, Kalipapa, Gamao, Karingayan and Sumonsang are hereby separated from their mother Barangay Litayen in the Municipality of Parang, Province of Maguindanao, and are created into a separate and distinct regular barangay to be known as Barangay Gadunganpedpandaran in the same municipality and province.

SEC. 2. Barangay Gadunganpedpandaran is bounded by natural and duly designated boundaries, more specifically defined as follows:

"Beginning at the boundary line of Barangay Tagudtungan on the North and up to the shores of Illana Bay beginning at Sitic Amay Martin up to Sitic Baclayan on the Eastern side; thence, on the Western direction indicating the boundary line of Barangay Limbayan on the South and going North along the barangay road separating Barangay Gadunganpedpandaran from Barangay Litayen on the West."

- SEC. 3. The seat of government shall be at Gandunganpedpandaran.
- SEC. 4. Immediately after the ratification of this Act, the punong barangay and seven (7) members of the sangguniang barangay shall be appointed by the mayor of Parang Municipality; while the chairman and seven (7) members of the sangguniang kabataan shall be appointed by the concerned punong barangay: Provided, That they shall hold office until their successors shall have been duly elected and qualified in their next sangguniang regular elections: Provided, Further, That they shall exercise their duties and powers specified under Republic Act 6734, Muslim Mindanao Autonomy Act 25, and other existing rules and regulations.
- SEC. 5. The corporate existence of Gandungan-pedpandaran shall commence upon the appointment and qualification of the punong barangay and a majority of the sangguniang barangay members.
- SEC. 6. The sangguniang bayan shall provide for the necessary allowances and other benefits of the appointed barangay officials out of the municipal funds until the regular allocation from the national government shall have been released to the new barangay.
- SEC. 7. The Commission on Elections shall conduct and supervise the plebiscite which shall be held within ninety (90) days after the approval of this Act.
- SEC. 8. The expenses required for the plebiscite shall be appropriated out of any available funds in the treasury of the municipality of Parang as may be determined by its sangguniang bayan.

SEC. 9. This Act shall take effect upon its approval.
