[MUSLIM MINDANAO AUTONOMY ACT NO. 172]

Begun and held in Cotabato City, on Monday the seventh day of January, two thousand two.

**AN ACT CREATING BARANGAY DAGEDEBAN-ADSOY IN THE MUNICIPALITY OF GENERAL SALIPADA K. PENDATUN, PROVINCE OF MAGUINDANAO, INTO A DISTINCT AND SEPARATE BARANGAY, AND FOR OTHER PURPOSES.**

Be it enacted by the Regional Legislative Assembly in session assembled:

SECTION 1.- The sitios of Dagedeban and Adsoy of Barangay Lower Idtig in the Municipality of Gen. S.K. Pendatun, province of Maguindanao, are hereby created into a distinct and separate Barangay to be known as Barangay Dagedeban-Adsoy in the said municipality.

SEC. 2.- The seat of government of Barangay Dagedeban-Adsoy shall be in Adsoy.

SEC. 3.- Barangay Dagedeban-Adsoy contains a land area of Six Hundred Seventy Five hectares, more or less, which shall be bounded as follows:

“Beginning at points 1 and 2 which bears N 88’48 E with a distance of 3,565 sq. M; 2 and 3, bearing S 28’32 E with a distance of 1,895 Sq. M; 3 and 4, bearing S 88’08 w with a distance of 3,565 sq. M; 4-1, bearing N 28’25 with a distance of 1,895 Sq. M.”

SEC. 4.- Immediately after ratification of this Act in a plebiscite, the Municipal Mayor concerned shall appoint the Barangay Chairman and the members of the Sangguniang Barangay in accordance with the pertinent provisions of Muslim Mindanao Autonomy Act No. 25, as amended, and its Implementing Rules and Regulations: Provided, That they shall exercise their duties and powers until their successors shall be elected and qualified in the regular Barangay election.

SEC. 5.- The corporate existence of Barangay Dagedeban-Adsoy shall commence upon the appointment or election and qualification of its Barangay Chairman and at least a majority of the members of the Sangguniang Barangay.

SEC.6.- As created, the municipality where this Barangay is located, shall allocate to its share from the Internal Revenue allotment based on the equal sharing system.

SEC. 7.- The Commission on Elections shall conduct and supervise the plebiscite for the purpose in the affected area within One Hundred Twenty (120) days form the approval of this Act.

SEC. 8.- The expenses necessary in holding the plebiscite shall be appropriated out of any available funds in the Gen. S.K. Pendatun Municipal Treasury.

SEC. 9.- The creation of Barangay Dagedeban-Adsoy shall take effect when approved by a majority of the votes cast in the plebiscite called for the purpose.

SEC. 10.- This Act shall take effect upon its approval.
