AN ACT APPROPRIATING SUPPLEMENTAL FUNDS FOR THE OPERATION OF THE AUTONOMOUS GOVERNMENT IN MUSLIM MINDANAO FOR FISCAL YEAR 2005 IN THE TOTAL AMOUNT OF SIXTY NINE MILLION PESOS, AND FOR OTHER PURPOSES.

Be it enacted by the Regional Legislative Assembly in session assembled:

SECTION. 1. Appropriation of Funds. – The amount of Sixty Nine Million Pesos is hereby appropriated as supplemental budget for fiscal year 2005 out of the local funds for the operation of the Regional Government.
