[MUSLIM MINDANAO AUTONOMY ACT NO. 252]

Begun and held in Cotabato City, on Monday, the twenty-seventh day of October, two thousand and eight.

**AN ACT AMENDING MUSLIM MINDANAO AUTONOMY ACT
NUMBERED TWO HUNDRED TWENTY FIVE,
PARTICULARLY SECTIONS ONE AND TWO THEREOF,
AND FOR OTHER PURPOSES.**

Be it enacted by the Regional Assembly in session assembled:

Section 1. - The original composition of the Municipality of Shariff Saydona Mustapha by barangays is hereby amended to read as follows:

“Section 1. - Barangays Nabundas, Dalembong, Datu Bakal, Datu Kilay of the Municipality of Shariff Aguak; barangays Pagatin, Pusao, Linantangan, Duguengen and part of Libutan (Libutan East) of the Municipality of Mamasapano; barangays Pamalian and Pikeg of the Municipality of Datu Unsay; barangay Dasawao of the Municipality of Datu Piang; and barangays Bakat, Ganta, Inaladan and part of Pagatin (Pagatin I) of the Municipality of Datu Saudi, all in the province of Maguindanao, are hereby separated from their respective Municipalities and are thus constituted into a distinct, separate and independent Municipality of Shariff Saydona Mustapha.”

Sec. 2. - Section 2 of said Muslim Mindanao Autonomy Act that defined and described its land area earlier is hereby amended to read as follows:

“Sec. 2. - The Land area of the municipality is described and defined or shall be founded as follows:
