[ **MUSLIM MINDANAO AUTONOMY ACT NO. 284** ]

Begun and held in Cotabato City, on Monday, the twenty-sixth day of October, two thousand and eight.

**AN ACT AMENDING MUSLIM MINDANAO AUTONOMY ACT NUMBERED ONE HUNDRED NINETY THREE, OTHERWISE KNOWN AS AN ACT CREATING THE MUNICIPALITY OF AKBAR IN THE PROVINCE OF BASILAN, AND FOR OTHER PURPOSES.**

Be it enacted by the Regional Legislative Assembly in session assembled:

**Section 1.** Section 1, Article I of MMA Act No. 193 is hereby amended, to read as follows:

“Section 1. Barangays Caddayan, Linungan, Lower Bato-Bato, Mangalut, Mangusu, Paguengan, Semut, Upper Bato-Bato and Sinangkapan are hereby separated from their mother Municipality and constituted into a distinct and independent local unit to be known as the Municipality of Akbar in the Province of Basilan.

The territorial jurisdiction of the Municipality shall be the existing metes and bounds of the above barangays as established when it was part of the Municipality of Tuburan, specifically as follows:
