BY THE PRESIDENT OF THE PHILIPPINES ADMINISTRATIVE ORDER No. 300

CREATING A NATIONAL COMMITTEE TO TAKE CHARGE OF THE THIRTEENTH ANNIVERSARY CELEBRATION OF THE REPUBLIC OF THE PHILIPPINES ON JULY 4, 1959

Pursuant to the powers vested in me by law, I, Carlos P. Garcia, President of the Philippines, do hereby create a National Committee to formulate plans and devise ways and means for the appropriate celebration of the Thirteenth Anniversary of the Republic of the Philippines on July 4, 1959.
