ADMINISTRATIVE ORDER NO. 464

CREATING AN EXECUTIVE COMMITTEE TO TAKE CHARGE OF THE PLAN-NING AND EXECUTION OF COMMEMORATIVE ACTIVITIES FOR THE FALL OF BATAAN, FALL OF CORREGIDOR AND BATTLE OF BESANG PASS.

WHEREAS, the Fall of Bataan, Fall of Corregidor and Battle of Besang Pass are milestones in our nation's history and

WHEREAS, it is fitting and proper to commemorate these historic events with appropriate activities to impress upon our people the valor and sacrifices of those who fought and died during our struggle for freedom and democracy;

NOW, THEREFORE, I, FERDINAND E. MARCOS, President of the Philippines, by virtue of the powers vested in me by law do hereby constitute and create an Executive Committee to formulate and devise ways and means for the successful execution of appropriate activities for the commemoration of the anniversary of the Fall of Bataan, Fall of Corregidor and Battle of Besang Pass.
