EXECUTIVE ORDER No. 51.

Executive Order Numbered Twenty-two, series of nineteen hundred and twelve, is hereby amended to read as follows:

"Pursuant to the provisions of Act Numbered Six hundred and forty-eight, Philippine Commision, entitled 'An Act authorizing the Governor-General to reserve for civil public purposes, and from sale or settlement, any part of the public domain not appropriated by law for special public purposes, until otherwise directed by law, and extending the provisions of Act Numbered Six hundred and twenty-seven so that public lands desired to be reserved by the Insular Government for public uses, or private lands desired to be purchased by the Insular Government for such uses, may be brought under the operation of the Land Registration Act,' I hereby reserve for provincial reservation purposes and withdraw from sale or settlement the following-described parcel of public domain in the sitio of Aborlan, barrio of Inagahuan, township of Puerto Princesa, Province of Palawan, Island

of Palawan, to wit: "Beginning at point marked 1 on plan Pn-27, identical with B. L. L. M. "Bounded on northeast by property of Insular Government (Iwahig Penal Colony, In-50); on southeast by public land, property of provincial government of Palawan (industrial school site, II-4757) and Sulu Sea; on northwest by public land and property of Insular Government (Iwahig Penal Colony, In-50). "Bearings true. Declination, 3° 35' E.

"Points referred to marked on plan Pn-27.

"Survey, January 27 to February 2, 1911. Approved, August 15, 1911.

"Amended to correct boundary and conflict with In-50 and Pn-27, approved May 7, 1913. "Note.—Corners 1, 36, 37, and 38 are ipil posts, 30 x 30 x

100 cm. with beveled edges on top, centered by G. I. nails. "With the exception of small clearings in the vicinity of

2-3=38-39, etc."

II-4757, practically the entire reservation covered with heavy virgin timber. "The coördinates of corners 1 to 38 are taken from II-4757. "Coördinates, as given for Pn-27, give line 1-2=1-38,
