BY THE PRESIDENT OF THE PHILIPPINES

EXECUTIVE ORDER No. 240

CONTINUING THE APPROPRIATIONS AUTHORIZED BY THE CONGRESS FOR THE OPERATION AND MAINTENANCE OF CERTAIN EXISTING ACTIVITIES OR SERVICES OF THE GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES DURING THE PERIOD FROM JULY 1, 1949 TO JUNE 30, 1950, AND FOR OTHER PURPOSES.

WHEREAS, the first Congress of the Philippines in its Fourth Session failed to provide appropriations for the period from July 1, 1949 to June 30, 1950 for the operation and maintenance of certain existing activities or services of the Government of the Republic of the Philippines authorized by special laws; and

Whereas, the absence of such appropriations will paralyze or discontinue said activities or services of the Government;

Now, THEREFORE, I, Elpidio Quirino, President of the Philippines, by virtue of the powers vested in me by the Constitution and existing laws, particularly Commonwealth Act No. 671, do hereby order:

SECTION. 1. The following sums appropriated by the Congress of the Philippines for the operation and maintenance of certain existing activities or services of the Government of the Republic of the Philippines for the fiscal year ending June 30, 1949, or so much thereof as may be necessary, are hereby continued for the same purposes, services, and activities for the fiscal year ending June 30, 1950:

SEC. 3. This Order shall take effect as of July 1, 1949.
