EXECUTIVE ORDER No. 13-A

MODIFYING THE RATES OF IMPORT DUTY ON CERTAIN IMPORTED ARTICLES AS PROVIDED UNDER REPUBLIC ACT NUMBER NINETEEN HUNDRED THIRTY-SEVEN, OTHERWISE KNOWN AS THE TARIFF AND CUSTOMS CODE OF THE PHILIPPINES.

Pursuant to the powers vested in me by section 401 of Republic Act Number Nineteen Hundred Thirty-Seven, I, Diosdado Macapagal, President of the Philippines, do hereby direct and order:

SECTION 1. The articles specifically listed hereunder as classified under section 104 of Republic Act Number Nineteen Hundred Thirty-Seven shall pay the following rates of import duty:
