EXECUTIVE ORDER NO. 161

CREATING THE MUNICIPALITY OF DON CARLOS IN THE PROVINCE OF BUKIDNON.

Pursuant to the provisions of Section 68 of the Revised Administrative Code, the barrios of Don Carlos Sur, Don Carlos Norte, Sinangguyan, Minsalagan, Kibatang, Manlammay, San Isidro, San Nicolas, Bershiba, Bocboc, San Francisco, Calaccalao, Kiara, Kalubihon, Old Nongnongan and other adjacent barrios and sitios, all of the municipality of Maramag, province of Bukidnon, are hereby segregated from said municipality and organized into an independent municipality in said province, to be known as the municipality of Don Carlos with the seat of government at the barrio of Don Carlos Sur.

The municipality of Don Carlos as herein organized shall have the following boundaries:

"From point 1, on the attached plan, located at the junction of Pulangui and Maramag rivers at longitude 1250-2'-00" E. with lathende 70-21-00" N. more or less; thence following through the Maramag river in northwesterly direction towards its upper stream at the head of the waterfall of said river at longitude 1250-11-00" E. and latitude 70-43'-00" N. to point 2; thence moving due west to the east side of Sayre Highway, distance of 700 meters to point 3; thence moving in the same direction to the opposite of said Highway a distance of 60 meters to point 4; thence moving due west toward the east bank of the Mulita river at longitude 124 -551-101 E. and latitude 70-421-50" N. a distance of 9 kilometers and 130 meters more or less to point 5; thence moving in the same course to the opposite side of same river a distance of 70 meters; thence moving due west until it reaches the east bank of Kidangguin river at longitude 124°-49'-00' E. and latitude 7°-42'-50" N. a distance of 10 kilometers point 7; thence moving in southerly direction following the center of said river towards the lower stream at longitude 1240-51'-00" E. and latitude 70-381-00" he more or less point 8; thence moving due east passing through the northmost and highest Peak of Rauban Hill located on the west of Bocboc marsh to the west bank of Mulita river at longitude 124°-56'-00'' E. and latitude $7^{\circ}-38'-00''$ N. distance of 10 kilometers and 150 meters to point 9; thence following the center of said river in northeasterly direction toward the upper stream until it reaches the junction of Kitaotao

creek and Mulita river otherwise known as M.B.M. No. 1 of Pls. #112 equivalent to point 10; thence following through the center of Kitaotao creek toward the upper stream until it reaches the Sayre Highway &t M.B.M. No. 3 of Pls. #112, as point 12; thence moving due east toward the west bank of the Pulangui river at longitude 125°-31'-00" E. with latitude 7°-39'-00" N. more or less to point 13; thence following through the center of the Pulangui river moving upper stream to point 1, point of beginning, containing an entire area of 18,450 hectares, more oe less. (Based on the technical description furnished by the Office of the Highway District Engineer of Bukidnon of the sketch plan or map of the proposed municipality of Don Carlos prepared by the said Office and on file in this Office, Scale: 1:50,000).

The municipality of Maramag shall have its present territory minus the portions thereof included in the municipality of Don Carlos, as delimited above.

The creation of this new municipality as proposed in House Bill No. 9010 was approved by the House of Representatives.

The municipality of Don Carlos shall begin to exist upon the appointment and qualification of the Mayor, Vice—Mayor and a majority of the councilors thereof and upon the certification by the Secretary of Finance that said municipality is financially capable of providing for all the statutory obligations and ordinary essential services of a regular municipality and that the mother municipality of Maramag after the segregation therefrom of the territory comprised in the municipality of Don Carlos, can still maintain creditably its municipal government, meet all its statutory and contractual obligations and provide for the essential municipal services.
