

PROCLAMATIONS
By the Governor General of the Philippine Islands

Proclamation No. 11

Pursuant to the provisions of section seventy-one of the Public Land Act, Numbered Nine hundred and twenty-six, I hereby designate for the use of the non-Christian tribes all of the public lands situated in the municipality of Tarlac, Province of Tarlac, Island of Luzon, hereinafter described by metes and bounds, and declare such lands as nonalienable and withdraw all of said lands from settlement, entry, sale, or other disposition under the public land laws of the Philippine Islands:

Beginning at a point marked 1 on plan K-26, on file in the Bureau of Lands, which point is S. $58^{\circ} 27'$ W. 999.98 m. from Bureau of Lands Barrio Monument No. 1, thence N. $31^{\circ} 33'$ W. 400.0 m. to point 2; N. $31^{\circ} 33'$ W. 400.0 m. to point 3; N. $31^{\circ} 33'$ W. 236.41 m. to point 4; N. $54^{\circ} 21'$ E. 314.87 m. to point 5; N. $88^{\circ} 04'$ E. 147.2 m. to point 6; S. $70^{\circ} 39'$ E. 102.84 m. to point 7; N. $77^{\circ} 02'$ E. 99.97 m. to point 8; S. $78^{\circ} 08'$ E. 108.32 m. to point 9; N. $85^{\circ} 20'$ E. 396.15 m. to point 10; N. $77^{\circ} 20'$ E. 112.48 m. to point 11; N. $17^{\circ} 59'$ E. 217.76 m. to point 12; N. $84^{\circ} 21'$ E. 107.98 m. to point 13; S. $16^{\circ} 16'$ E. 311.71 m. to point 14; S. $32^{\circ} 45'$ E. 269.59 m. to point 15; S. $7^{\circ} 04'$ W. 68.49 m. to point 16; S. $15^{\circ} 30'$ W. 25.55 m. to point 17; S. $21^{\circ} 32'$ E. 48.47 m. to point 18; S. $84^{\circ} 40'$ E. 106.16 m. to point 19; S. $41^{\circ} 47'$ E. 55.57 m. to point 20; S. $46^{\circ} 59'$ W. 206.33 m. to point 21; S. $36^{\circ} 50'$ E. 116.33 m. to point 22; S. $9^{\circ} 45'$ E. 165.29 m. to point 23; S. $68^{\circ} 23'$ W. 65.67 m. to point 24; S. $31^{\circ} 33'$ E. 317.45 m. to point 25; S. $58^{\circ} 27'$ W. 1,000.00 m. to point 26; N. $31^{\circ} 33'$ W. 800.0 m. to point 1, point of beginning.

Containing 1,957,624 square meters.

Point 3 is a P. L. S./B. L. monument; points 5 to 13, inclusive, on bank of Cabanatuan or Moriones River; points 14 to 24, inclusive, on bank of Sapang Duglu.

Bounded on northeast by Sapang Duglu and public lands; on southeast and southwest by public lands; on northwest by public lands, sapa, and Cabanatuan or Moriones River.

Bearings true. Declination, $0^{\circ} 27'$ E.

Land surveyed July 23-30, 1912. Plan approved October 30, 1912.
