PROCLAMATION NO. 73

RESERVING FOR HEADQUARTERS SITE PURPOSES OF THE BOY SCOUTS OF THE PHILIPPINES SOUTH COTABATO-GENERAL SANTOS CITY COUNCIL. A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN SITUATED IN THE MUNICIPALITY OF KORONADAL, PROVINCE OF SOUTH COTABATO, ISLAND OF MINDANAO.

Upon recommendation of the Minister of Natural Resources and pursuant to the powers vested in me by law, I, CORAZON C. AQUINO, President of the Philippines, do hereby withdraw from sale or settlement and reserve for headquarters site purposes of the BSP South Cotabato-General Santos City Council under the administration of the Boy Scouts of the Philippines, subject to private rights, it any there be, a certain parcel of land of the public domain, situated in the Eunicipality of Koronadal, Province of South Cotabato, island of Mindanao, more particularly described as follows:

Lot 880-A, Csd-11-002404

A PARCEL OF LAND (Lot 880-A, Csd-11-002404) situated in Poblacion, Municipality of Koronadal, Province of South Cotabato, Island of Mindanao. Bounded on the SE., along line 1-2 by Alunan Avenue; on the SW., NW., N., and NE., along lines 2-3-4-1 by Lot 880-B, Csd-11-002404. Beginning at a point marked "1" of Lot 880-A, Csd-11-002404, being N. 79-48' W., 2845.20 m. from Triangulation Station "Tukadillas";
