PROCLAMATION NO. 642

EXCLUDING FROM THE OPERATION OF PROCLAMATION NO. 163, DATED FEBRUARY 13, 1967, WHICH ESTABLISHED THE KASIBU FOREST RESERVE, SITUATED IN THE MUNICIPALITY OF KASIBU, PROVINCE OF NUEVA VIZCAYA, A PARCEL OF LAND EMBRACED THEREIN, AND RESERVING THE SAME FOR SCHOOL SITE PURPOSES OF THE KASIBU NATIONAL AGRICULTURAL SCHOOL

Upon recommendation of the Secretary of Environment and Natural Resources and pursuant to Section 18 of Presidential Decree No. 705, otherwise known as the Revised Forestry Code of the Philippines, I, CORAZON C. AQUINO, President of the Philippines, do hereby exclude from the operation of Proclamation No. 163, dated February 13, 1967, which established the Kasibu Forest Reserve situated in the Municipality of Kasibu, Province of Nueva Vizcaya, a parcel of land embraced therein, and reserving the same for school site purposes of the Kasibu National Agricultural School, subject to private rights, if any there be, as shown in C.R. Map No. 381, which is more particularly described as follows:

Beginning at a point designated as corner "1" which * is identical to corner 114, Timberland, Project No. 11-B of Kasibu, Nueva Vizcaya;

Thence, S 02 degrees W, 180 meters to corner 2; Thence, S 63 degrees W, 326 meters to corner 3; Thence, S 80 degrees W, 350 meters to corner 4; Thence, S 05 degrees E, 210 meters to corner 5; Thence, S 73 degrees W, 342 meters to corner 6; Thence, S 37 degrees W, 172 meters to corner 7; Thence, N 47 degrees W, 145 meters to corner 8; Thence, S 82 degrees W, 210 meters to corner 9; Thence, S 40 degrees E, 245 meters to corner 10; Thence, S 57 degrees W, 160 meters to corner 11; Thence, S 79 degrees W, 180 meters to corner 12; Thence, N 87 degrees W, 290 meters to corner 13; Thence, N 33 degrees E, 343 meters to corner 14; Thence, N 31 degrees E, 560 meters to corner 15; Thence, N 45 degrees E, 540 meters to corner 16; Thence, N 56 degrees E, 206 meters to corner 17; Thence, N 69 degrees E, 192 meters to corner 18; Thence, S 61 degrees E, 318 meters to corner 19; Thence, S 85 degrees E, 130 meters to corner 20; Thence, S 59 degrees E, 180 meters to point of

beginning, containing an area of NINETY FIVE (95.0) HECTARES, more or less.

- 1. The administration and management of the area covered by the reservation shall be under the Department of Education, Culture and Sports. For this purpose, a five-year development plan shall be submitted to the Office of the President of the Philippines by the Principal of the said school within one (1) year from the approval hereof, furnishing the Department of Environment and Natural Resources and the Forest Management Bureau copies thereof.
- 2. The timber and other forest products remaining in the area shall be conserved and protected and their extraction and utilization if ever allowed shall be subject to Forest and Internal Revenue Laws and Regulations.
- 3. In the event that the area is no longer needed for the purpose stated, or its development has already been abandoned for a period of two (2) years, this proclamation is automatically withdrawn, revoked or cancelled and the subject area regains its original status as part and parcel of the forest land.
- 4. The subject area which is within the Kasibu Forest Reserve established under Proclamation No. 163, dated February 13, 1967, is hereby excluded from the operation of said proclamation.

IN WITNESS WHEREOF, I have hereunto set my hand and caused the seal of the Republic of the Philippines to be affixed.
