PROCLAMATION NO. 819

AMENDING PROCLAMATION NO. 2005, DATED SEPTEMBER 5, 1980, WHICH ESTABLISHED THE RESERVATION FOR UNSPECIFIED PUBLIC PURPOSES OF BARANGAY MADIANGAT A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN SITUATED IN SAID BARANGAY, MUNICIPALITY OF QUEZON, PROVINCE OF NUEVA VIZCAYA, ISLAND OF LUZON, BY EXCLUDING FROM ITS OPERATION THE RESIDENTIAL AREAS EMBRACED THEREIN AND DECLARING THE EXCLUDED PORTION OPEN TO DISPOSITION UNDER THE PROVISIONS OF THE PUBLIC LAND ACT; AND RESERVING THE REMAINING AREA SPECIFICALLY FOR SCHOOL SITE AND PUBLIC PLAZA PURPOSES

Upon recommendation of the Secretary of Environment and Natural Resources and by virtue of the powers vested in me by law, I, CORAZON C. AQUINO, President of the Philippines, do hereby amend Proclamation No. 2005, dated September 5, 1980 which established the reservation for public purposes of Barangay Madiangat of a certain parcel of land of the public domain situated in said Barangay, Municipality of Quezon, Province of Nueva Vizcaya, Island of Luzon, by excluding from its operation the residential areas embraced therein and declaring the excluded portions open to disposition under the provisions of the Public Land ACt, as amended; and reserving the remaining parcels of land specifically for school site and public plaza purposes, as hereunder indicated and more particularly described as follows:

Lot 78, Gss-2-03-000125 Public Plaza

A PARCEL OF LAND (Lot 78, Gss-2-03-000125) situated in Barangay Madiangat, Municipality of Quezon, Province of Nueva Vizcaya, Island of Luzon. Bounded on the Sw., along line 1-2 by Road (10.00 m. wide); on the Nw., and NE., along lines 2-3-4 by Road (6.00 m. wide); and on the SE., along line 4-1 by Road (10.00 m. wide). Beginning at a point marked "1" of Lot 78, Gss-2-03-000125, being N. 59 deg. 24' E., 925.04 m. from MBM # 17;

Bounded on the W., NW., and NE., along lines 1-2-3-4 by Road (10.00 m. wide); on the E., along line 4-5 by Road (6.00 m. wide); and on the S., along line 5-1 by Provincial Road. Beginning at a point marked "1" of Lot 1, Gss-2-03-000125, being N. 66 deg. 48' E., 819.49 m. from MBM # 17;

thence N. 15 deg. 23'E., 114.47 m. to point 2;

- N. 29 deg. 25'E., 28.18 m. to point 3; S. 59 deg. 05'E., 149.10 m. to point 4;
