PROCLAMATION NO 84

ESTABLISHING AS MOUNT MASARAGA WATERSHED FOREST RESERVE FOR THE PURPOSE OF PROTECTION, MAINTENANCE AND IMPROVEMENT OF ITS WATER YIELD AND TO PROVIDE RESTRAINING MECHANISM FOR INAPPROPRIATE FOREST EXPLOITATION AND DISRUPTIVE LAND-USE, A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN SITUATED IN THE MUNICIPALITIES OF POLANGUI, OAS, LIGAO AND TABACO, PROVINCE OF ALBAY, ISLAND OF LUZON

Upon recommendation of the Secretary of Environment and Natural Resources and pursuant to the powers vested in me by law, I, FIDEL V. RAMOS, President of the Philippines, do hereby withdraw from entry, sale, disposition or settlement and set aside as Mount Masaraga Watershed Forest Reserve, subject to private rights, if any there be, and to the operations of previous proclamations reserving any portion thereof for specific purposes, and to the implementation of socially-oriented projects and other forestry development programs consistent with the objectives of the proclamation as may be determined by the Secretary of Environment and Natural Resources, a certain parcel of land of the public domain, located in the Municipalities of Polangui, Oas, Ligao and Tabaco, Province of Albay, as shown in the Forest Management Bureau Map WR No. 97 with the following descriptions:

Beginning at point "1" on the map is a point which is identical to MBM No. 12 of Tabaco, Albay;

Thence S 36°E, 2,000 meters to corner 2, stake;

Thence N 75°E, 350 meters to corner 3, stake;

Thence S 38°E, 2,000 meters to corner 4, stake;

Thence S 12°E, 300 meters to corner 5, identical to corner 41, Blk 1, Proj. 12 A & D;

Thence S 67°W, 850 meters to corner 6, identical to corner 40, Blk 1, Proj. 12 A & D;

Thence S 83°W, 650 meters to corner 7, identical to corner 39, Blk 1, Proj. 12 A & D;

Thence S 85°W, 600 meters to corner 8, identical to corner 38, Blk 1, Proj. 12 A & D;



Thence S 84°W, 500 meters to corner 9, identical to corner 37, Blk 1, Proj. 12 A & D;

Thence N 56°W, 200 meters to corner 10, identical to corner 36, Blk 1, Proj. 12 A & D;

Thence N 71°W, 300 meters to corner 11, identical to corner 35, Blk 1, Proj. 12 A & D;

Thence N 38°W, 230 meters to corner 12, identical to corner 34, Blk 1, Proj. 12 A & D;

Thence N 26°W, 475 meters to corner 13, identical to corner 19, Blk 1, Proj. 15 A & D;

Thence N 15°E, 275 meters to corner 14, identical to corner 18, Blk 1, Proj. 15 A & D;

Thence N 65°W, 200 meters to corner 15, identical to corner 17, Blk 1, Proj. 15 A & D;

Thence N 24°W, 250 meters to corner 16, identical to corner 16, Blk 1, Proj. 15 A & D;

Thence N 45°W, 400 meters to corner 17, identical to corner 15, Blk 1, Proj. 15 A & D;

Thence following creek to a Northeast direction, 350 meters to corner 18, identical to corner 14, Blk 1, Proj. 15, A & D;

Thence following creek to a Northeast direction, 350 meters to corner 19, identical to corner 13, Blk 1, Proj. 15, A & D;

Thence following creek to a Northeast direction, 300 meters to corner 20, identical to corner 12, Blk 1, Proj. 15, A & D;

Thence N 24°W, 450 meters to corner 21, identical to corner 11, Blk 1, Proj. 15 A & D;

Thence N 57°W, 350 meters to corner 22, identical to corner 10, Blk 1, Proj. 15 A & D;

Thence N 19°W, 400 meters to corner 23, identical to corner 9, Blk 1, Proj. 15 A & D;

Thence N 54°E, 350 meters to corner 24, identical to corner 6, Blk 1, Proj. 15 A & D;

Thence N 54°E, 350 meters to corner 25, identical to corner 5, Blk 1, Proj. 15 A & D;



Thence N 36°E, 250 meters to corner 26, identical to corner 4, Blk 1, Proj. 15 A & D;

Thence N 15°E, 300 meters to corner 27, identical to corner 3, Blk 1, Proj. 15 A & D;

Thence N 44°E, 250 meters to corner 28, identical to corner 2, Blk 1, Proj. 15 A & D;

Thence N 60°E, 30 meters to corner 1, the point of beginning containing an area of EIGHT HUNDRED TEN (810.00) HECTARES, more or less.


The area covered by the reservation shall be under the administrative jurisdiction, supervision and control of the Department of Environment and Natural Resources, through its Forest Management Bureau, in coordination with other agencies of the government with the objective of maintaining its usefulness as a source of water for irrigation and domestic use and other forestry purposes.
