PROCLAMATION NO. 85

RESERVING FOR RESETTLEMENT SITES OF THE AETA COMMUNITIES
CERTAIN PARCELS OF LAND OF THE PUBLIC DOMAIN LOCATED AT
BARANGAY CAWAG, MUNICIPALITY OF SUBIC, PROVINCE OF
ZAMBALES, ISLAND OF LUZON

In consideration of the urgent need to assist the families affected by the eruption of Mt. Pinatubo by providing them with suitable resettlement and livelihood areas conducive to their economic recovery, and upon recommendation of the Secretary of Environment and Natural Resources and by the powers vested in me by law, I, FIDEL V. RAMOS, President of the Philippines, do hereby reserve for resettlement and livelihood purposes, subject to private rights if any, and to future classification, certain parcels of land, which are more particularly described as follows:

Lot - 1, SWO-037114-000191

A PARCEL OF LAND (Lot-1, SWO-037114-000191, being a portion of Lot 4008, Cad. 547-D, Subic Cadastre), situated in barangay Cawag, Municipality of Subic, Province of Zambales, Island of Luzon. Bounded on the northeast by Lot-4, SWO-037114-000191; on the southeast by Lot-2, SWO-03-037114-000191; and on the southwest by portion of Lot 4008, Subic Cadastre. Beginning at a point "1" on the survey plan, being N. 21 deg. 18'W, 1,316.20 meters from BLLM No. 5, Cad. 547-D, Subic Cadastre,

Bounded in the north by portion of Lot 4262, Cad. 547-D, Subic Cadastre (Project No. 13-H, Block 1, Timberland per LC Map No. 665); on the southeast by Block II, on the south by Barangay road; on the southwest by Lot 3, 2, and 1, SWO-037114-000191 and on the west by Project 13, Block I, alienable and disposable area. Beginning at a point marked "1" on the plan, being N. 07 deg. 56'E., 1,097.05 meters from BLLM No. 5 Cad. 547-D, Subic Cadastre.

Lots 1-3, are inside the alienable and disposable area, Project No. 13, Block 1, L.C. Map No. 665 while Lot-4 is inside Project No. 13-H, Block I, Timberland, L.C. Map 665.

The lots within this Proclamation shall be disposed of through Stewardship Contract under the Integrated Social Forestry Program inasmuch as the area is presently classified as Public Land, subject to appropriate modes of disposition under the Public Land Law, as amended, should there be a reclassification later.
