## PROCLAMATION NO. 86

RESERVING FOR RESETTLEMENT SITE PURPOSES OF THE MOUNT PINATUBO VICTIMS CERTAIN PARCELS OF LAND OF THE PUBLIC DOMAIN LOCATED AT BARANGAYS TAUGTOG AND SAN JUAN, MUNICIPALITY OF BOTOLAN, PROVINCE OF ZAMBALES, ISLAND OF LUZON

In consideration of the urgent need to assist the families affected by the eruption of Mt. Pinatubo by providing them with suitable resettlement and livelihood areas conducive to their economic recovery, and upon recommendation of the Secretary of Environment and Natural Resources and the Presidential Task Force created under Memorandum Order No. 369, dated June 26, 1991, and by the powers vested in me by law, I, FIDEL V. RAMOS, President of the Philippines, do hereby reserve for resettlement and livelihood purposes, subject to private rights if any, and to future classification and survey, a certain parcels of land of the public domain situated in the Barangays of Taugtog and San Juan, Municipality of Botolan, Province of Zambales, Island of Luzon and more particularly described as follows:

### PARCEL 1

A PARCEL OF LAND (being a portion of Lot 1690, Botolan Cad. 614-D, as shown in the attached Sketch Plan) situated in Barangay Taugtog, Municipality of Botolan, Province of Zambales, Island of Luzon. Bounded on the South, along lines 1-3 by Lot 1684; on the Southwest and Northwest, along lines 3-9 by Lot 1690 (portion); on the East, along line 9-10 by parcel 2 of this Proclamation, (which is a portion of Lot 5731); on the South, along lines 10-13 by Lot 1687, along line 13-14 by Lot 1686 and along line 14-1 by Lot 1685, all of Botolan Cadastre. Beginning at a point marked "1", being N. 56 deg. 18'E., 5,024.52 meters from BLLM No. 1, Botolan Cadastre,

A PARCEL OF LAND (Being a portion of Lot 5731, Botolan Cad. 641-D, as shown in the attached Sketch Plan) situated in Barangay San Juan, Municipality of Botolan, Province of Zambales, Island of Luzon. Bounded on the South and Southwest, along line 1-2 by portion of Lot 5731, along lines 2-4 by Lot 5735, along line 4-5 by Lot 5685, along lines 5-7 by Lot 5697; on the West, along lines 7-14 by Lot 1687, along line 14-15 by Parcel 1 of this Proclamation, (which is a portion of Lot 1690); and on the North, Northeast and Southeast, along lines 15-25-1 by portion of Lot 5731, all of Botolan Cadastre. 
The lots within this Proclamation shall be disposed of through stewardship contract under the Integrated Social

A

Forestry Program inasmuch as the area is presently classified as forest zone, subject to appropriate modes of disposition under the Public Land Law, as amended, should there be a reclassification later.
