## BY THE PRESIDENT OF THE PHILIPPINES

## PROCLAMATION NO. 915

ESTABLISHING AS CALABGAN WATERSHED FOREST RESERVE FOR PURPOSES OF PROTECTING, MAINTAINING, OR IMPROVING THE WATER YIELD AND PROVIDING RESTRAINING MECHANISM FOR INAPPROPRIATE FOREST EXPLOITATION AND DISRUPTIVE LAND-USE A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN SITUATED IN THE MUNI-CIPALITY OF CASIGURAN, PROVINCE OF AURORA, ISLAND OF LUZON, PHILIPPINES

Upon recommendation of the Secretary of Environment and Natural Resources and pursuant to the powers vested in me by law, I, CORAZON C. AQUINO, President of the Philippines, do hereby withdraw from entry, sale, disposition or settlement and set aside as Calabgan River Watershed Forest Reserve, subject to private rights, if any there be, and to the operations of previous proclamations reserving any portion thereof for specific purposes, and to the implementation of sociallyoriented projects and other forestry development programs consistent with the objectives of the proclamation as maybe determined by the Secretary of Environment and Natural Resources, a certain parcel of land of the public domain situated in the Municipality of Casiguran, Province of Aurora, Island of Luzon, Philippines, as shown in the Forest Management Bureau Map No. WR 100 with the following descriptions:

Beginning at point 1 on the map, which is identical to the junction of Calabgan and Abuleg Rivers;

Thence S 10° 00' W, 755 meters to corner 2, a point located at the junction of Calabgan and Abuleg Rivers;

Thence S 35° 00' W, 910 meters to corner 3, a point located on the ground;

Thence S 75° 00' W, 1,230 meters to corner 4, a point on the ground:

Thence S 73° 00' W; 1,060 meters to corner 5, a point on the ground;

Thence S 80° 00' W, 1,080 meters to corner 6, a point on the ground;

Thence N 62° 00' W, 915 meters to corner 7, a point on top of ridge;

Thence N 86° 00' W, 1,200 meters to corner 8, a point on the ground;

Thence N 37° 00' W, 500 meters to corner 12, a point at the peak elevation, 1,055 meters;

Thence Due North, 995 meters to corner 13, a point on the ground;

Thence N 79° 00' E, 1,080 meters to corner 14, a point on the ground

Thence N 38° 00' E, 1,010 meters to corner 15, a point near peak elevation, 948 meters;

Thence N 30° 00' E, 625 meters to corner 16, a point on the ground;

Thence N 27° 00' E, 1,010 meters to corner 17, a point on the ground;

Thence N 35° 00' E, 1,390 meters to corner 18, a point on the ground;

Thence N 60° 00' E, 1,220 meters to corner 19, a point on top of the ridge;

Thence S 30° 00' E, 1,056 meters to corner 24, a point on the ground;

Thence Due South, 1,205 meters to corner 1, a point of beginning containing an area of FOUR THOUSAND EIGHT HUNDRED THREE AND 44/100 (4,803.44) HECTARES.

The area covered by the reservation shall be under the administrative jurisdiction, supervision and control of the Department of Environment and Natural Resources, through its Forest Management Bureau, in coordination with other agencies of the government with the objective of maintaining its usefulness as a source of water for irrigation and domestic use and other forestry purposes.
