PROCLAMATION NO.484

RESERVING FOR SCHOOL SITE PURPOSES OF THE CAUSWAGAN ELEMENTARY SCHOOL A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN SITULTED IN BARANGAY CAUSWAGAN, MUNI-CIPALITY OF LILOY, PROVINCE OF ZAMEOANGA DEL NORTE, ISLAND OF MINDANAO

Upon recommendation of the Secretary of Environment and Natural Resources and by virtue of the powers vested in me FIDEL V. RAMOS, President of the Philippines, by law, I, hereby withdraw from sale or settlement and reserve for do school site purposes of the Causwagan Elementary School under the administration of the Department of Education, Culture and Sports, subject to private rights, if any there be, a certain parcel of land of the public domain situated in Barangay Causwagan, Municipality of Liloy, Province of Norte, Island of Mindanao, which Zamboanga del is more particularly described as follows:

Lot 3, Ccs-09-07-000029-D (School Site)

A PARCEL OF LAND (Lot 3, Ccs-09-07-000029-D) situated in Barangay Causwagan, Municipality of Liloy, Province of Zamboanga del Norte, Island of Mindanao.
