PROCLAMATION NO. 532

DELINEATING THE METES AND BOUNDS OF THE SUBIC SPECIAL ECONOMIC AND FREEPORT ZONE ESTABLISHED PURSUANT TO REPUBLIC ACT NO. 7227, OTHERWISE KNOWN AS THE "BASES CONVERSION AND DEVELOPMENT ACT OF 1992", APPROVED MARCH 13, 1992

Upon recommendation of the OIC-Secretary of Environment and Natural Resources and the Chairman and Administrator of the Subic Bay Metropolitan Authority, I, FIDEL V. RAMOS, President of the Philippines, by virtue of the powers vested in me by law, do hereby designate the metes and bounds of the Subic Special Economic and Freeport Zone, otherwise known as the Subic Bay Freeport, consisting of the city of Olongapo and the municipality of Subic, province of Zambales, the lands occupied by the Subic Naval Base and its contiguous extensions as embraced, covered, and defined by the 1947 Military Bases Agreement between the Philippines and the United States of America as amended, and within the territorial jurisdiction of the Municipalities of Morong and Hermosa, Province of Bataan, and the Municipality of San Antonio, Province of Zambales, as follows:

The boundaries and limits of the Subic Freeport Zone are described by the following technical descriptions:

Bounded on the W and NW along pts. 1 to 7 by the South China Sea beginning at a point of origin marked "1" located at Binictican Pt. with a bearing of S 79° 08' 18" W, 1920.25 m to pt. 2 located at Sampaloc Point; thence line 2 - 3 with a bearing of N 70° 47' 07" W, 6421.72 m to point 3 located at Silanguin Island; thence line 3 - 4 with a bearing of N 32° 16' 33" W having a distance of 4118.27 m; thence line 4 - 5 with a bearing of N 05° 33' 08" W having a distance of 2965.74 m; thence line 5 - 6 with a bearing of N 14° 51' 48" W having a distance of 4361.41 m; thence line 6 - 7 with a bearing of N 05° 39' 36" E having a distance of 1265.83 m; bounded along line 7 - 8 on the NE by Twin Peaks with a bearing of N 48° 45' 17" E having a distance of 1995.26 m; thence bounded along line 8 - 9 on the N by Mount Pink with a bearing of N 89° 46' 10" E having a distance of 7712.96 m; bounded along line 9 - 10 on NE by Mount Casagoton with a bearing of N 48° 25' 04" E having a distance of 922.27 m; bounded

along line 10 - 11 on NE traversing through Mt. Cawag with a bearing of N 86° 36' 42" E having a distance of 1467.66 m; thence bounded along line 11 - 12 on the NE by Barrio Namapagan with a bearing of N 46° 13' 55" E having a distance of 2700.02 m; bounded along line 12 - 13 on the NE by Barrios Balaybay and Sakatihan with a bearing of N 50° 21' 57" E having a distance of 7135.65 m; bounded on NE by line 13 - 14 with a bearing of N 74° 31' 25" E having a distance of 1707.11 m; bounded along line 14 - 15 on the NE by Mount Mabolinoc with a bearing of N 79° 24' 20" E having a distance of 7726.69 m; bounded on the NE by line 15 - 16 with a bearing of N 64° 57' 50" E having a distance of 1948.57 m; bounded on the NE by line 16 - 17 with a bearing of N 75° 49' 13" E having a distance of 5335.58 m; bounded on the NE by line 17 - 18 with a bearing of N 55° 42' 51" E having a distance of 978.20 m; bounded on the north by line 18 - 19 with a bearing of N 88° 21' 59" E having a distance of 986.48 m; bounded on the SE along line 19 - 20 by Barrio Pabanlag with a bearing of S 33° 01' 46" E having a distance of 6389.13 m; bounded on the S and SW along points 20 to 26 by the municipality of Dinalupihan, thence, line 20 - 21 with a bearing of S 34° 09' 16" W having a distance of 3633.44 m; line 21 - 22 with bearing of S 27° 45' 10" W having a distance of 3225.39 m; line 22 - 23 with a bearing of S 39° 31' 33" W having a distance of 1272.27 m; line 23 - 24 with a bearing of S 87° 38' 24" W having a distance of 3500.99 m; line 24 - 25 with a bearing of S 72° 18' 43" W having a distance of 2606.77 m; line 25 - 26 with a bearing of S 55° 44' 33" W having a distance of 1630.96 m; bounded by line 26 - 27 on the N and NE following road alignment with a bearing of N 86° 37' 20" E having a distance of 2486.17 m; line 27 - 28 with a bearing of S 07° 51' 27" W having a distance of 1116.47 m; bounded on the S and SE along line 28 - 29 by Layac River with a bearing of S 15° 28' 21" E having a distance of 2329.77 m; line 29 - 30 with a bearing of S 35° 15' 07" E having a distance of 1960.91 m; line 30 - 31 with a bearing of S 15° 41' 39" W having a distance of 669.88 m; line 31 - 32 with a bearing of S 28° 14' 07" E having a distance of 943.28 m; thence line 32 - 33 with a bearing of S 12° 39' 33" W having a distance of 2486.91 m; bounded along line 33 - 34 by Mount Sta. Rosa with a bearing of S 33° 24' 37" W having

a distance of 3491.23 m; bounded along line 34 - 35 on the S by Mount Silanganan with a bearing of S 83° 48' 36" W having a distance of 6380.53 m; bounded on S by line 35 - 36 with a bearing of N 84° 24' 47" W having a distance of 2283.48 m with Pt. 36 located at Dapua Pt; thence along line 36 - 37 with a bearing of S 79° 24' 48" W having a distance of 2466.37 m following the shoreline with pt. 37 located at Buin Pt. and pt. 37 to pt. of origin on the S with a bearing of N 84° 43' 17" W having a distance of 8678.81 m.

Total land and water area is sixty seven thousand four hundred fifty two (67,452) hectares more or less.

NOTE: ALL DATA are approximate and subject to change based on future surveys

Pending the establishment of secure perimeters around the Subic Bay Freeport, the Subic Bay Metropolitan Authority pursuant to the Bases Conversion and Development Act of 1992 (R.A. No. 7227) is authorized to adopt and implement the gradual and phased operation of areas within the Subic Bay Freeport to ensure strict compliance with the aforesaid Act, its implementing Rules and Regulations, and other Philippine laws.

The maintenance and protection of the proclaimed Watershed Reservations and natural resources within the Subic Bay Freeport shall be vested in the Subic Bay Metropolitan Authority.
