PROCLAMATION NO. 824

**RESERVING FOR MILITARY SITE PURPOSES OF CAMP BRIGADIER GENERAL HERMINIGILDO A. AGAAB, JR. A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN SITUATED IN PULUTANA, BARANGAY BATOMELONG, GENERAL SANTOS CITY, ISLAND OF MINDANAO**

Upon the recommendation of the Secretary of Environment and Natural Resources and by virtue of the powers vested in me by law, I, FIDEL V. RAMOS, President of the Philippines, do hereby withdraw from sale or settlement, and reserve for military site purposes of Camp Brigadier General Herminigildo Agaab, Jr. under the Administration of the Department of National Defense, subject to private rights, if any there be, certain parcels of land of the public domain situated at Pulutana, Batomelong, General Santos City, Island of Mindanao, more particularly described as follows:

**LOT 1, Ccs-116303-000566-D**

A PARCEL OF LAND, Lot 1, Ccs-116303-000566-D, equivalent to Lot 1365, a consolidation subdivision of Lots 1297, 671, 946 and Lot 947, Pls-553, situated in the Barrio of Batomelong (now) City of General Santos, Island of Mindanao. Bounded on the NE., along line 1-2 by Lot 2, Ccs-116303-000566-D, on the S., along line 2-3 by Lot 496, Pls-553; on the SW., along 3-4 by National Highway; on the NW., along line 4-5 by Lot 945-A, Csd-11-009140-D; and along line 5-1 by Lot 2, Ccs-116303-000566-D.
