PROCLAMATION NO. 1046

RESERVING FOR SCHOOL SITES PURPOSES OF THE ANDILI ELEMENTARY
AND HIGH SCHOOLS CERTAIN PARCELS OF LAND OF THE PUBLIC
DOMAIN SITUATED IN BARANGAY ANDILI, MUNICIPALITY OF
MAWAB, PROVINCE OF DAVAO DEL NORTE, ISLAND OF MINDANAO

Upon recommendation of the Secretary of Environment and Natural Resources and by virtue of the powers vested in me by law, I, FIDEL V. RAMOS, President of the Philippines, do hereby withdraw from sale, entry, disposition or settlement and reserve for school sites purposes under the administration of the Department of Education, Culture and Sports, subject to private rights, if any there be, certain parcels of land of the public domain situated in Barangay Andili, Municipality of Mawab, Province of Davao del Norte, Island of Mindanao, which parcels of land are more particularly described as follows:

Lot 12515-A, Csd-11-010267-D
equivalent to Lot 13670, Cad-282
(Andili Elementary School Site)

A PARCEL OF LAND, Lot 12515-A, Csd-11-010267-D, being a portion of Lot 12515, Cad-282, (before Lot 109-C, Csd-11-006615-D) situated in Barangay Andili, Municipality of Mawab, Province of Davao del Norte, Island of Mindanao. Bounded on the E., along line 1-2 by Lot 12515-B, Csd-11-010267-D (equivalent to Lot 13671, Cad-282), on the S., along 2-3 by road; on the W., along lines 3-4-5 by Lot 108, Cad-282; and on the N., along line 5-1 by Lot 12514, Cad-282 (before Lot 109-B, Csd-11-006615-D). Beginning from point marked "1" on plan being S. 77° 43' E., 567.42 m. from BLLM No. 11, Cad-282, thence:

S. 05° 24' E.,	196.83 m. to point 2;
S. 81° 11' W.,	130.20 m. to point 3;
N. 05° 16' W.,	159.34 m. to point 4;

All points referred to are indicated on the plan and are marked on the ground as follows: Corners 3 and 4 by Old BL Cyl. Conc. Mons. 15 x 60 cm. corner 5 by Old PS Cyl. Conc. Mons. 15 x 60 cm. and the rest by PS Cyl. Conc. Mons. Bearings true.

Lot No. 12515-B, Csd-11-010267-D
(Andili High School Site)

A PARCEL OF LAND, Lot 12515-B, Csd-11-010267-D, being a portion of Lot 12515, Cad-282 (Lot 109-C, Csd-11-006615-D) situated in Barangay Andili, Municipality of Mawab, Province of Davao del Norte, Island of Mindanao. Bounded on the N., along line 1-2 by Lot 12514, Cad-282 Compostela Cadastre (Lot 109-B, Csd-11-006615-D) on the E., along line 2-3 by Lot 12513, Cad-283, Compostela Cadastre (Lot 109-A, Csd-11-006615-D) on the S., along lines 3-4-5 by Road; and on the W., along line 5-1 by Lot 12515-A, Csd-11-010267-D (Equivalent to Lot 13670, Cad-282, Compostela Cadastre) Andili Elementary School Site. Beginning at a point marked "1" on plan being S. 77-43 E., 567.42 from B.L.L.M. 11, Cad-282, Compostela Cadastre, thence:



beginning, containing an area of THIRTEEN THOUSAND (13,000) SQUARE METERS. All points referred to are indicated on the plan and are marked on the ground as follows: point 2 and 3 by Old PS Cyl. Conc. Mons. 15 x 60 cm. Bearings true. Date of Survey April 24, 1989 by Geodetic Engineer Pacifico E. Garcia and approved on May 22, 1989.
