### PROCLAMATION NO. 992

AMENDING PROCLAMATION NO. 313, DATED SEPTEMBER 1, 1988, WHICH RESERVED FOR SLUM IMPROVEMENT AND RESETTLEMENT (SIR) PROGRAM BY GRANTING OWNERSHIP TO THE NATIONAL HOUSING AUTHORITY OF A PARCEL OF LAND OF THE PUBLIC DOMAIN SITUATED IN THE CITY OF DAVAO, ISLAND OF MINDANAO

Upon recommendation of the Secretary of Environment and Natural Resources and pursuant to the authority vested in me by law, I, FIDEL V. RAMOS, President of the Philippines, do hereby amend Proclamation No. 313, dated September 1, 1988, which reserved a certain parcel of land for the Slum Improvement and Resettlement (SIR) Program of the National Housing Authority by granting ownership to the said agency of a parcel of land which is more particularly described as follows:

SWO-11-000507  
(Dried Creek)

A PARCEL OF LAND (Swo-11-000507, Dried Creek), situated in the Barrio of New Matina, City of Davao, Island of Mindanao. Bounded on the SE., & S., along lines 1-2-3-4-5 by Lot 395, Cad-102; on the S., along line 5-6 by Lot 396, Cad-102; on the S., along line 6-7 by National Road; on the W., NW., & N., along lines 7-8-9-10-11-12 by Lot 379 Cad-102; and on the E., along line 12-1 by Upgrading area (N.H.A.).

Beginning at a point marked "1", being S. 5 deg. 34'E., 733.49 m. from Mon #9, Davao Townsite; thence:

beginning, containing an area of TWO THOUSAND THREE HUNDRED TWELVE (2,312) SQUARE METERS. All points referred to are indicated on the pland and are marked on the ground by P.S. Cyl. Conc. Mons. 15 x 60 cm. Bearings true. This lot was surveyed in accordance with the law and existing regulations promulgated thereunder by Jaime M. Maglana, Geodetic Engineer, on December 14, 1984, and was approved on January 11, 1985.

NOTE: This is additional Lot 9291, Cad-102, Davao Cadastre formerly a portion of Cabacan Creek.
