

BY THE PRESIDENT OF THE PHILIPPINES

PROCLAMATION NO. 1236

ESTABLISHING AS ALFRED SPRING WATERSHED FOREST RESERVE, FOR THE PURPOSE OF PROTECTING, MAINTAINING, OR IMPROVING ITS WATER YIELD AND PROVIDING RESTRAINING MECHANISM FOR INAPPROPRIATE FOREST EXPLOITATION AND DISRUPTIVE LAND-USE, A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN SITUATED AT BARANGAY SAN ANDRES, MUNICIPALITY OF BUNAWAN, PROVINCE OF AGUSAN DEL SUR

Upon the recommendation of the Secretary of the Department of Environment and Natural Resources and by virtue of the powers vested in me by law, I, FIDEL V. RAMOS, President of the Philippines, do hereby withdraw from entry, sale, disposition, or resettlement and set aside as Alfred Spring Watershed Forest Reserve subject to private rights, if any there be, and to the operations of previous proclamations reserving any portion thereof for specific purposes, and to the implementation of other forestry development programs consistent with the objectives of the proclamation as may be determined by the Secretary of the Department of Environment and Natural Resources, a certain parcel of land of the public domain situated at Barangay San Andres, Municipality of Bunawan, Province of Agusan del Sur as shown in the map WR-123, more particularly described as follows:

Beginning at point "1" on the map, being North 67°01'9.47" East, 1,490.358 meters from BBM No. 4, Cad. 945-D, Bunawan Cadastre; thence:

N 02°55' E,	300.00 m. to corner 2,
S 87°05' E,	1,250.00 m. to corner 3,
S 10°23' W,	880.47 m. to corner 4,
N 83°25' W,	781.22 m. to corner 5,
N 83°25' W,	356.71 m. to corner 6,
N 02°55' E,	500.23 m. to corner 1,

the point of beginning, containing an area of One Hundred (100.00) hectares, more or less.

All boundaries are subject to actual survey and establishment of permanent corner monuments.


