PROCLAMATION NO. 78

RESERVING FOR SCHOOL SITE PURPOSES OF PRESIDENT QUIRINO CENTRAL SCHOOL A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN SITUATED IN THE MUNICIPALITY OF PRESIDENT QUIRINO, PROVINCE OF SULTAN KUDARAT, ISLAND OF MINDANAO

Upon recommendation of the Secretary of Environment and Natural Resources and by virtue of the powers vested in me by law, I, JOSEPH EJERCITO ESTRADA, President of the Philippines, do hereby withdraw from sale, entry, disposition, or settlement and reserve for school site purposes of the President Quirino Central Elementary School under the administration of the Department of Education, Culture and Sports, subject to private rights, if any there be, a certain parcel of land situated in Poblacion, Municipality of President Quirino, Province of Sultan Kudarat, Island of Mindanao, which parcel is more particularly described as follows:

LOT 10695, PLS-73 (IDENTIFICATION TO LOT 2, CCS-12-000052-D)

A PARCEL OF LAND (Lot 10695, Pls-73, identical to Lot 2, Ccs-12-000052-D, being a portion of Lot 784, 7819 and Road, Pls-73, Buluan Public Land Subdivision) situated in Poblacion, Municipality of President Quirino, Province of Sultan Kudarat. Bounded on the SE., along line 1-2 by Road, 15.00 m wide; on the SE., and SW., along lines 2-3-4-5 by Lot 6899, Pls-73; on the W., along line 5-6 by Lot 1 of the Consolidation Subdivision Plan; Ccs-12-000052-D; on the NW., along line 6-7 by Lot 783, Pls-73; on the N., along line 7-8 by Lot 3 (National Highway 60.00 m. wide of the Consolidation-Subdivision Plan Ccs-12-000052-D identical to Lot 10696, Pls-73); along line 8-9 by National Highway 60.00 m. wide; along line 9-10 by Lot 5, (National Highway 60.00 m. wide of the Consolidated Subdivision Plan, Ccs-12-000052-D, identical to Lot 10698, Pls-73); and on the SE., along lines 10-11-1 by Road 15.00 m. wide.
