PROCLAMATION NO. 190

CREATING AND DESIGNATING CERTAIN PARCELS OF LAND OF THE PRIVATE DOMAIN SITUATED AT BARANGAY CANNERY, MUNICIPALITY OF POLOMOLOK, PROVINCE OF SOUTH COTABATO AS SPECIAL ECONOMIC ZONE PURSUANT TO REPUBLIC ACT NO. 7916 AS AMENDED BY REPUBLIC ACT NO. 8748
