

**BY THE PRESIDENT OF THE PHILIPPINES**

**PROCLAMATION NO. 363**

**CREATING AND DESIGNATING A PARCEL OF LAND OF THE PRIVATE DOMAIN LOCATED AT EPIFANIO DELOS SANTOS AVENUE (EDSA) CORNER PIONEER STREET, BARANGAY (BARRANCA) ILAYA, MANDALUYONG CITY AS INFORMATION TECHNOLOGY PARK PURSUANT TO REPUBLIC ACT 7916 AS AMENDED BY REPUBLIC ACT NO. 8748**

Pursuant to the powers vested in me under Republic Act No. 7916, Special Economic Zone Act of 1995, as amended by Republic Act No. 8748 (An Act amending Republic Act No. 7916), **I, GLORIA MACAPAGAL-ARROYO**, President of the Republic of the Philippines, do hereby create and designate as an Information Technology Park, pursuant to the provision of Republic Act No. 7916 as amended, its Implementing Rules and Regulations, and Resolutions Nos. 00-411 and 00-262, dated 29 December 2000 and 17 August 2000 respectively, of the Board of the Directors of the Philippine Economic Zone Authority, a parcel of land located at EDSA corner Pioneer Street, Barangay (Barranca) Ilaya, Mandaluyong City, consisting of **SIXTY EIGHT THOUSAND FIVE HUNDRED NINETY SIX (68,596) SQUARE METERS**, more or less, as defined by the following technical descriptions:

A PARCEL OF LAND (Consolidation Plan, Pcn-00-001016, of Lot 1-A, Psd-34073, Lot 1, (LRA) Psc-32403 & Lots 1-B-1 & 1-B-2, Psd-34912, LRC Record Nos. 699, 875 & 917), situated in Brgy. of (Barranca) Ilaya, City of Mandaluyong, Metro Manila, Island of Luzon.
