PROCLAMATION NO. 638

RESERVING FOR SCHOOL SITE PURPOSES OF THE KAUSWAGAN ELEMENTARY SCHOOL CERTAIN PARCELS OF LAND OF THE PUBLIC DOMAIN SITUATED IN KAUSWAGAN, PANABO CITY, DAVAO DEL NORTE, ISLAND OF MINDANAO
