PROCLAMATION NO. 660

RESERVING FOR OFFICE SITE PURPOSES OF THE CEBU CITY ASSOCIATION OF BARANGAY COUNCIL (ABC) A CERTAIN PARCEL OF LAND OF THE PUBLIC DOMAIN SITUATED AT CORNER D. JAKOSALEM AND M.C. BRIONES STREETS, BARANGAY CENTRAL PROPER, CITY OF CEBU, ISLAND OF VISAYAS

Upon recommendation of the Secretary of Department of Environment and Natural Resources, and by virtue of the powers vested in me by law, I, **GLORIA MACAPAGAL-ARROYO**, President of the Republic of the Philippines do hereby withdraw from sale, entry, disposition or settlement and reserve certain parcel of land of the public domain, subject to private rights, if any there be, under the administration of the Local Government Unit, situated in Barangay Central Proper, City of Cebu, Island of Visayas and more particularly described as follows:

SK-07-000031

A PARCEL OF LAND, (Proposed Cebu City ABC Hall, as described on Sketch Plan, SK-07-000031), situated in the barrio of Central Proper, City of Cebu, Island of Visayas. Bounded on the NW., along line 1-2 by M.C. Briones Street; on the NE., along line 2-3 by D. Jakosalem Extension; on the SE., along line 3-4 by Bureau of Customs (Port Area); and on the SW., along line 4-1 by public land. Beginning at a point marked "1" on plan being S. 88-01' W., 372.53 meters from BLLM No. 1, Cad-12, Cebu Cadastre; thence:
