PROCLAMATION NO. 740

RESERVING CERTAIN PARCELS OF LAND OF THE PUBLIC DOMAIN IN APLAYA, DIGOS, DAVAO DEL SUR, ISLAND OF MINDANAO AS OFFICE AND NURSERY SITES OF THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES — PROVINCIAL OFFICE

Upon recommendation of the Secretary of Environment and Natural Resources, and by virtue of the powers vested in me by law, I, GLORIA MACAPAGAL-ARROYO, President of the Republic of the Philippines, do hereby reserve parcels of land of the public domain situated at Aplaya, Digos, Davao del Sur, identified as Lot Nos. 2 and 3, Block 430, TS-11-000048, containing an aggregate area of TWELVE THOUSAND NINE HUNDRED NINETY NINE (12,999) SQUARE METERS, more or less, as office and nursery sites of the Department of Environment and Natural Resources – Provincial Office (PENRO), subject to private rights, if any there be, which parcels of land are more particularly described as follows:

Lot No. 2, Block 430, Ts-11-000048 (PENR OFFICE SITE)

A parcel of land, (Lot 2, block 430, Ts-11-000048) (As-11-000212), situated at Barangay Aplaya, Municipality of Digos, Province of Davao del Sur, Island of Mindanao.
