PROCLAMATION NO. 763

CREATING AND DESIGNATING PARCELS OF LAND OF THE PRIVATE DOMAIN SITUATED IN THE CITY OF CEBU, ISLAND OF CEBU, WHICH IS A PORTION OF THE CEBU CITY SOUTH RECLAMATION PROJECT, AS SPECIAL ECONOMIC ZONE PURSUANT TO REPUBLIC ACT NO. 7916 AS AMENDED BY REPUBLIC ACT NO. 8748

Pursuant to the powers vested in me under Republic Act No. 7916, otherwise known as the Special Economic Zone Act of 1995, as amended by Republic Act No. 8748, and upon the recommendation of the Board of Directors of the Philippine Economic Zone Authority, **I, GLORIA MACAPAGAL-ARROYO**, President of the Republic of the Philippines, by virtue of the powers vested in me by law, do hereby create and designate as Special Economic Zone, subject to the provisions of Republic Act No. 7916, as amended, its Implementing Rules and Regulations, and Resolution No. 97-273 dated 18 August 1997 of the Board of Directors of the Philippine Economic Zone Authority, an area located at the City of Cebu, Island of Cebu, which is a portion of the Cebu City South Reclamation Project, consisting of **TWO MILLION NINE HUNDRED FIFTY SIX THOUSAND NINE HUNDRED TWENTY NINE (2,956,929) SQUARE METERS**, more or less, as defined by the following technical description:

## Lot 1 SK-07-000037

A parcel of land (Lot 1, SK-07-000037), situated at City of Cebu, Island of Cebu.
