PROCLAMATION NO. 866

**RESERVING CERTAIN PARCELS OF LAND OF THE PUBLIC DOMAIN
LOCATED IN MIAG-AO, ILOILO AS SITE OF THE UNIVERSITY OF THE
PHILIPPINES-VISAYAS AND GRANTING OWNERSHIP OF THE SAME
IN FAVOR OF THE UNIVERSITY OF THE PHILIPPINES-VISAYAS**

Upon recommendation of the Secretary of Environment and Natural Resources, and by virtue of the powers vested in me by law, **I, GLORIA MACAPAGAL ARROYO**, President of the Republic of the Philippines, do hereby reserve certain parcels of land of the public domain located in Miag-Ao, Iloilo containing an aggregate area of **TWO MILLION TWO HUNDRED SEVENTY TWO THOUSAND FIVE HUNDRED TWENTY EIGHT (2,272,528) SQUARE METERS**, subject to private rights, if any there be, as site of the University of the Philippines-Visayas and granting ownership of the same in favor of the University of the Philippines-Visayas, which parcels of land are more particularly described as follows:

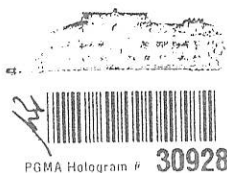

The tracts of land herein reserved shall be used exclusively for educational purposes and shall be non-alienable nor subject to occupation, entry, sale lease or other disposition until again declared alienable by proclamation of the President.

The Secretary of the Department of Environment and Natural Resources is hereby authorized to issue a Special Patent covering the area herein reserved for school site purposes in favor of the University of the Philippines-Visayas.
