

BY THE PRESIDENT OF THE PHILIPPINES

PROCLAMATION NO. 934

CREATING AND DESIGNATING A PROPOSED BUILDING TO BE ESTABLISHED ON A PARCEL OF LAND LOCATED AT SM CENTRAL BUSINESS PARK, BAY CITY, PASAY CITY, AS INFORMATION TECHNOLOGY BUILDING PURSUANT TO REPUBLIC ACT NO. 7916, AS AMENDED BY REPUBLIC ACT NO. 8748

Pursuant to the powers vested in me under Republic Act No. 7916, the Special Economic Zone Act of 1995, as amended by Republic Act No. 8748, and upon recommendation of the Board of Directors of the Philippine Economic Zone Authority, I, GLORIA MACAPAGAL-ARROYO, President of the Republic of the Philippines, do hereby create and designate as Information Technology Building, subject to the provisions of Republic Act No. 7916 as amended, its Implementing Rules and Regulations, and Resolution No. 00-411 dated 29 December 2000 and Resolution No. 05-248 dated 28 July 2005, of the Board of Directors of the Philippine Economic Zone Authority (PEZA), a proposed building to be established on a parcel of land located at SM Central Business Park, Bay City, Pasay City, Metro Manila, containing an area of TWENTY TWO THOUSAND FORTY EIGHT (22,048) SQUARE METERS, more or less, as defined by the following technical descriptions:

Lot 1 (Portion of Lot 2-B)
Psd-00-068705

A parcel of land (Lot 1 of the subdivision plan Psd-00-068705, being a portion of Lot 2 Pcs-00-010536, L.R.C. Record No. A-1), situated in the City of Pasay, Province of Metro Manila, Island of Luzon. Bounded on the NE., SE., SW., along lines 1-28 by Lot 2 of the subdivision plan; on the NW., along line 28-1 by Road Lot 1 Pcs-00-010536.
