**PROCLAMATION NO. 1099**

**RESERVING FOR LAGUINDINGAN RELOCATION SITE PURPOSES CERTAIN  
PORTION OF THE PUBLIC DOMAIN SITUATED IN THE BARRIO OF  
TUBAJON, MUNICIPALITY OF LAGUINDINGAN, PROVINCE OF  
MISAMIS ORIENTAL ISLAND OF MINDANAO**

By virtue of the powers vested in me by Law, **I, GLORIA MACAPAGAL-ARROYO**, President of the Republic of the Philippines and upon the recommendation of the Secretary of the Department of Environment and Natural Resources, do hereby set aside and proclaim, subject to private rights, if there be any, certain parcel of the public domain of Laguindingan, Misamis Oriental for relocation site purposes for the inhabitants of Laguindingan, Misamis Oriental who were displaced by the establishment or creation of the Laguindingan International Airport as shown and described in C.R. Map No. FMB-00 which parcel of land is more particularly described as follows:

Tubajon Laguindingan, Misamis Oriental  
Island of Mindanao**

A PARCEL OF LAND (Lot 155-A, GSS-880, Cad-237, Cagayan Cadastre) situated in Barangay Tubajon, Municipality of Laguindingan, Province of Misamis Oriental, Island of Mindanao. To the point of beginning; containing an area of **THREE HUNDRED FORTY FOUR THOUSAND TWO HUNDRED NINETEEN (344,219) SQUARE METERS** more or less. Subject to final ground survey."

The administration and management of the area covered by the reservation shall be under the Local Government Unit of Laguindingan, Misamis Oriental in coordination with the Department of Environment and Natural Resources, and any development activity therein shall have minimal effect to the ecosystem. For this purpose a five-year development plan shall be submitted to the Office of the President of the Republic of the Philippines, within one (1) year from approval hereof, furnishing the Department of Environment and Natural Resources through the Forest Management Bureau a copy thereof.

The cutting and utilization of timber and other forest products remaining in the area shall be subject to Forestry and Revenue Laws and Regulations.
