PROCLAMATION NO. 1128

CREATING AND DESIGNATING THE JY SQUARE IT CENTER II SITUATED AT SALINAS DRIVE, BARANGAY LAHUG, CEBU CITY, ISLAND OF CEBU AS INFORMATION TECHNOLOGY CENTER PURSUANT TO REPUBLIC ACT NO. 7916 AS AMENDED BY REPUBLIC ACT NO. 8748

Pursuant to the powers vested in me under Republic Act No. 7916, the Special Economic Zone Act of 1995 as amended by Republic Act No. 8748 and upon recommendation of the Board of Directors of the Philippine Economic Zone Authority (PEZA), **I, GLORIA MACAPAGAL-ARROYO**, President of the Republic of the Philippines, by virtue of the powers vested in me by law, do hereby create and designate as **Information and Technology Center**, subject to the provisions of Republic Act No. 7916 as amended, its Implementing Rules and Regulations, and Resolutions Nos. 00-411 and 06-001 dated 29 December 2000 and 10 January 2006 respectively, of the PEZA Board of Directors, the JY Square IT Center II, which stands on a 4,036-square meter lot, more or less, located at Salinas Drive, Lahug, Cebu City, as defined by the following technical descriptions:

A parcel of land (Lot 2-C-2-B of the subdivision plan Psd-07-01-000944, being a portion of Lot 2-C-2, described on plan (LRC), Psd-271949, L.R.C. (GLRO) Rec. No. 5988), situated in the City of Cebu, Island of Cebu. Bounded on the SW. along line 1-2 by Lot 2-E (LRC) Psd-268773; on the NW. along lines 2-3-4-5 by Lot 1 (LRC) Psd-21568, on the NE. along line 5-6 by Lot 2-C-1 (LRC) Psd-271949, and on the SE. along line 6-1 by Lot 2-C-2-A of the subdivision plan. Beginning at a point marked "1" on plan, being N. 4 deg. 18' W. 1037.79 m. from Mon. 5 Banilad Estate; thence, N. 66 deg. 08' W. 66.92 m. to point 2; N. 15 deg. 38' E. 44.58 m. to point 3; N. 36 deg. 00' E. 10.63 m. to point 4; N. 33 deg. 12' E. 4.27 m. to point 5; S. 66 deg. 31' E. 66.26 m. to point 6; S. 19 deg. 53' W. 59.32 m. to the point of; beginning; containing an area of Four Thousand Thirty Six (4,036) Square Meters, more or

All points referred to are indicated on the plan and are marked on the ground as follows; point 6; by P.S. cyl. conc. mons. 15 x 60 cms., and the rest by Old P.S. cyl. conc. mons. 15 x 60 cms., bearings true; date of the original survey, August 1906-July 1907, and that of the subdivision survey, on March 22, 1978.
