PROCLAMATION NO. 1885

CREATING AND DESIGNATING A PARCEL OF LAND OF THE PRIVATE DOMAIN SITUATED AT BARANGAY MARIA CRISTINA, MUNICIPALITY OF BALO-I, PROVINCE OF LANAO DEL NORTE, ISLAND OF MINDANAO, AS AGRO-INDUSTRIAL ECONOMIC ZONE PURSUANT TO REPUBLIC ACT NO. 7916 AS AMENDED BY REPUBLIC ACT NO. 8748

Pursuant to the powers vested in me under Republic Act No. 7916, otherwise known as the Special Economic Zone Act of 1995 as amended by Republic Act No. 8748 and upon the recommendation of the Board of Directors of the Philippine Economic Zone Authority, **I, GLORIA MACAPAGAL-ARROYO**, President of the Philippines, do hereby create and designate, subject to the provisions of Republic Act No. 7916 as amended, its Implementing Rules and Regulations, Resolution No. 07-232 dated 16 May 2007 and Resolution No. 08-470 dated 10 September 2008, of the Board of Directors of the Philippine Economic Zone Authority, a parcel of land located at Barangay Maria Cristina, Balo-I, Lanao del Norte as agro-industrial economic zone to be known as Balo-I Agro-Industrial Economic Zone, with an area of **One Hundred Thirty Nine Thousand Twelve (139,012) Square Meters**, more or less, as defined by the following technical description:

"Pcn-10-000326

A parcel of land (Plan Pcn-10-000326), being consolidation plan of Lot 4503, CAD-292 & Lot 2, Pcs-10-0003055, situated in the Barangay Maria Cristina, Municipality of Balo-I, Province of Lanao del Norte, Island of Mindanao.

Bounded on the NE., along lines 19-1-2-3 by Overton Military Reservation; along lines 3-4-5-6 by Road; along line 6-7 by Lot 1 (Road Pcs-10-003055; on the SE., along line 7-8-9-10 by Lot 1 (LRC) Psd-26647 (Portion of Lot 2296, Cad-292); on the SE., along line 10-11 by property of Catalina Sajulga; along lines 11 to 17 by Agus River (30.00 m. wide non-navigable); and on the NW., along lines 17-18-19 by Lot 2255, Cad-292, Iligan Cadastre. Note:Portion of this lot is subject to legal easement (3.00 m. wide) along lines 11-12-&17-18.

Beginning from a point marked "1" on the plan being N. 57 deg. 00 W., 7244.97 m. from BLLM No. 1, Momungan, Balo-I, Lanao del Norte.
