PROCLAMATION NO. 2026

CREATING AND DESIGNATING SEVERAL PARCELS OF LAND LOCATED AT BARANGAYS TAMBO AND DONGALO, PARAÑAQUE CITY, AS TOURISM ECONOMIC ZONE PURSUANT TO REPUBLIC ACT NO. 7916 AS AMENDED BY REPUBLIC ACT NO. 8748

Pursuant to the powers vested in me under Republic Act No. 7916, otherwise known as the Special Economic Zone Act of 1995, as amended, and upon recommendation of the Board of Directors of the Philippine Economic Zone Authority, **I**, **GLORIA MACAPAGAL ARROYO**, President of the Philippines, do hereby create and designate, subject to the provisions of Republic Act No 7916, as amended, its Implementing Rules and Regulations and Resolution No. 02-342 dated 10 October 2002 and Resolution No. 08-615 dated 28 November 2008, as amended by Resolution No. 09-622 dated 07 December 2009, of the Board of Directors of the Philippine Economic Zone Authority, several parcels of land located at Barangays Tambo and Dongalo, Parañaque City as tourism economic zone to be known as **Okada Resorts**, with an aggregate area of **Four Hundred Seven Thousand Nine Hundred Ninety Three (407,993) Square Meters**, more or less, as defined by the following consolidated technical description:
