PROCLAMATION NO. 2051

PROPOSED PROCLAMATION RESERVING A CERTAIN OF LAND OF THE PUBLIC DOMAIN AS SCHOOL SITE PURPOSES FOR SAN JULIAN ELEMENTARY SCHOOL, SITUATED IN BARANGAY SAN JULIAN NORTE, CITY OF VIGAN, PROVINCE OF ILOCOS SUR, ISLAND OF LUZON AND GRANTING OWNERSHIP THEREOF IN FAVOR OF THE REPUBLIC OF THE PHILIPPINES-DEPARTMENT OF EDUCATION (RP-DepEd)

Upon the recommendation of the Secretary of Environment and Natural Resources and by virtue of the powers vested in me by law, **I, GLORIA MACAPAGAL-ARROYO**, President of the Republic of the Philippines, do hereby withdraw from sale or settlement and reserve as school site purpose for **San Julian Elementary School** and granting ownership thereof in favor of the Republic of the Philippines -Department of Education (RP-DepEd), a certain parcel of land of the public domain subject to private rights, if any there be, if any there be, situated in Barangay San Julian Norte, City of Vigan, Province of Ilocos Sur, Island of Luzon and more particularly described as follows:

**"Lot 649, Cad 313-D, Ap-01-007222, Vigan Cadastre
SAN JULIAN ELEMENTARY SCHOOL**

A PARCEL OF LAND (Lot 649, Cad 313-D, Ap-01-007222), Vigan Cadastre) situated at Barangay San Julian Norte, City of Vigan, Province of Ilocos Sur, Island of Luzon.
