PROCLAMATION NO. 2106

AMENDING PROCLAMATION NO. 1485 DATED 11 APRIL 2008,
CREATING AND DESIGNATING THE ENTIRE PHIVIDEK
INDUSTRIAL ESTATE LOCATED AT THE MUNICIPALITIES OF
VILLANUEVA AND TAGOLOAN, PROVINCE OF MISAMIS
ORIENTAL AS SPECIAL ECONOMIC ZONE PURSUANT TO
REPUBLIC ACT NO. 7916 AS AMENDED BY REPUBLIC ACT NO.
8748

Pursuant to the powers vested in me under Republic Act No. 7916, otherwise known as the Special Economic Zone Act of 1995 as amended and upon the recommendation of the Board of Directors of the Philippine Economic Zone Authority, I, **GLORIA MACAPAGAL-ARROYO**, President of the Philippines, do hereby create and designate, subject to the provisions of Republic Act No. 7916, as amended, its Implementing Rules and Regulations, and Resolution No. 08-047 dated 22 January 2008 as amended by Resolution No. 08-151 dated 13 March 2008 and Resolution No. 10-161 dated 19 April 2010 of the Board of Directors of the Philippine Economic Zone Authority, the Phividec Industrial Estate located at the Municipalities of Villanueva and Tagoloan, Province of Misamis Oriental, as a Special Economic Zone, consisting of **Three Thousand (3,000) Hectares**, more or less, as contained in the following technical description:

**"Phividec Industrial Estate
SWO 10-000065**

A parcel of land situated in the barrios of Casinglot, Sagbongcogan, Garcia, Baluarte, Puluc, Balot, Sta. Cruz, Calsada and Polo of the Municipality of Tagoloan and barrios Nabacaan, Domo, Balacanas, Tambobong, Dalamba, San Martin, Dinogon, Kirahon, and Kiamo of the Municipality of Villanueva, all in the Province of Misamis Oriental. Boundary appearing on the topo-map herewith attached and used as reference.

Beginning from pt. '1' on plan, at the mouth of Taganga Creek, southwest of the Poblacion of Villanueva.
