**PROCLAMATION NO. 2109**

**AMENDING PROCLAMATION NO. 367 DATED MAY 2, 1994 WHICH RESERVED A CERTAIN PARCEL OF LAND IN STA. ANA DISTRICT, DAVAO CITY AS OFFICE SITE FOR THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, REGION XI, BY SEGREGATING A PORTION THEREOF AND RESERVING THE SAME AS OFFICE SITE FOR THE OFFICE OF THE OMBUDSMAN-MINDANAO**

Upon the recommendation of the Secretary of the Department of Environment and Natural Resources, and by virtue of the powers vested in me by law, - **I, GLORIA MACAPAGAL-ARROYO**, President of the Republic of the Philippines, do hereby segregate a portion of the land covered by Proclamation No. 367, s. 1994 for the DENR Regional Office Building, located in Sta. Ana District, City of Davao, containing an area of 2,085 square meters, and reserve **ONE THOUSAND SQUARE METERS** of its as the site for the OMB-Mindanao office building, more particularly described as follows:
