PROCLAMATION NO. 566

CREATING AND DESIGNATING A PARCEL OF LAND LOCATED AT MAC ARTHUR HIGHWAY, MATINA, DAVAO CITY, AS AN INFORMATION TECHNOLOGY PARK, PURSUANT TO REPUBLIC ACT NO. 7916, AS AMENDED BY REPUBLIC ACT NO. 8748

Pursuant to the powers vested in me under Republic Act (RA) No. 7916, otherwise known as the Special Economic Zone Act of 1995, as amended by RA No. 8748, and upon the recommendation of the Board of Directors of the Philippine Economic Zone Authority (PEZA), I, BENIGNO S. AQUINO III, President of the Philippines, do hereby create and designate, subject to the provisions of RA No. 7916, as amended, its Implementing Rules and Regulations, Resolution No. 00-411 (s. 2000), as amended by Resolution No. 04-295 (s. 2004), and Resolution No. 11-625 (s. 2011) of the PEZA Board of Directors, a parcel of land located at Mac Arthur Highway, Matina, Davao City, as an Information Technology Park, to be known as Matina IT Park, consisting an area of Seventeen Thousand Nine Hundred Ninety (17,990) Square Meter, more or less, as defined by the following technical description:

Lot 392-C-3-B TCT No. T-276953 Psd-11-053755

A parcel of land (Lot 392-C-3-B, Psd-11-053755), being a portion of Lot 392-C-3, Psd-68502, situated in the City of Davao, Island of Mindanao.

Bounded on the NE., along line 3-4 by Lot 392-C-2, Psd-68502; on the SE., along line 4-1 by Lot 392-C-3-A (Road Widening) of the subdivision plan; on the SW., along line 1-2 by the Lot 393-B; and on the NW., along line 2-3 by Lot 392-H, both of Psd-24499.

Beginning at a point marked "1" on plan, being S. 31 deg. 11'E., 1724.94 m. from BBM No. 11, Cad-102, Davao Cadastre.
