## PROCLAMATION NO. 579

# CREATING AND DESIGNATING A BUILDING WHICH STANDS ON A LAND, LOCATED AT SHAW BOULEVARD CORNER SAN MIGUEL AVENUE, ORTIGAS CENTER, PASIG CITY, AS AN INFORMATION TECHNOLOGY CENTER, PURSUANT TO REPUBLIC ACT NO. 7916, AS AMENDED BY REPUBLIC ACT NO. 8748

Pursuant to the powers vested in me under Republic Act (RA) No. 7916, otherwise known as the Special Economic Zone Act of 1995, as amended by RA No. 8748, and upon the recommendation of the Board of Directors of the Philippine Economic Zone Authority (PEZA), I, **BENIGNO S. AQUINO III**, President of the Philippines, do hereby create and designate, subject to the provisions of RA No. 7916, as amended, its Implementing Rules and Regulations, Resolution Nos. 00-411 (s. 2000) and 10-081 (s. 2010) of the PEZA Board of Directors, an existing building, as an Information Technology (IT) Center, known as **One San Miguel Avenue Condominium**, which stands on a land, located at Shaw Boulevard corner San Miguel Avenue, Ortigas Center, Pasig City, containing an area of **One Thousand Five Hundred Sixty-Eight (1,568) Square Meters**, more or less, as defined by the following technical description:

# Lot 8, Block 14, (LRC) Psd-105493 (Rel-00-001441) TCT No. PT-99585
