# PROCLAMATION NO. 817

## CREATING AND DESIGNATING SEVERAL PARCELS OF LAND, LOCATED AT KM. 48 MC ARTHUR HIGHWAY, BARANGAY IBA ESTE, SAN MARCOS AND PALIMBANG, CALUMPIT, BULACAN, AS A SPECIAL ECONOMIC ZONE, PURSUANT TO REPUBLIC ACT NO. 7916, AS AMENDED BY REPUBLIC ACT NO. 8748

Pursuant to the powers vested in me under Republic Act (RA) No. 7916, or the "Special Economic Zone Act of 1995," as amended by RA No. 8748, and upon recommendation of the Board of Directors of the Philippine Economic Zone Authority (PEZA), **I**, **BENIGNO S. AQUINO III**, President of the Philippines, do hereby create and designate several parcels of land, subject to the provisions of RA No. 7916, as amended, its Implementing Rules and Regulations, and Resolution No. 12-607 (s. 2012) of the PEZA Board of Directors, as a **Special Economic Zone**, located at Km. 48 Mc Arthur Highway, Barangay Iba Este, San Marcos and Palimbang, Calumpit, Bulacan, to be known as the **P&S Ecozone** with an aggregate area of **Four Hundred Thirty Seven Thousand Thirty-Seven square meters and Eighty square decimeters (437,037.80)**, more or less, as defined by the following technical description:

## Lot No. 1-B-2, Psd-03-072553

A parcel of land (Lot 1-B-2 of the subdivision plan Psd-03-072553, being a portion of Lot 1-B, [LRC] Psd-346892, LRC Rec. No.) situated in Barangay Iba Este, Municipality of Calumpit, Province of Bulacan, Island of Luzon.
