PROCLAMATION NO.1194

CREATING AND DESIGNATING SEVERAL PARCELS OF LAND, LOCATED AT  
BARANGAYS BULIHAN, LUTA NORTE AND LUTA SUR, MALVAR,  
BATANGAS, AS A SPECIAL ECONOMIC ZONE, PURSUANT TO REPUBLIC  
ACT NO. 7916, AS AMENDED BY REPUBLIC ACT NO. 8748

Pursuant to the powers vested in me under Republic Act (RA) No. 7916, or the "Special Economic Zone Act of 1995," as amended by RA No. 8748, and upon the recommendation of the Board of Directors of the Philippine Economic Zone Authority (PEZA), I, **BENIGNO S. AQUINO III**, President of the Philippines, do hereby create and designate several parcels of land, subject to the provisions of RA No. 7916, as amended, its Implementing Rules and Regulations, Resolution 13-743 (s. 2013), as amended by Resolution 15-314 (s. 2015), and Resolution No. 13-339 (s. 2013), as amended by Resolution Nos. 14-033 (s. 2014) and 15-274 (s. 2015), of the PEZA Board of Directors, located at Barangays Bulihan, Luta Norte and Luta Sur, Malvar, Batangas, as a **Special Economic Zone**, to be known as the **Light Industry and Science Park IV**, with an aggregate area of **Six Hundred Forty-Five Thousand Nine Hundred Seventy-Seven (645,977) square meters**, more or less, as defined by the following consolidated technical description:
